### What is it like to attend this early years setting?

### The provision is good

Children thrive in the care of this highly experienced childminder. They follow their own interests as they choose activities. The childminder skilfully builds on what they know as they play. She teaches them how to share toy food during a teddy bear's picnic. She extends their vocabulary as they use their imaginations to create different foods using play dough. The childminder enthusiastically plays hide and seek with them. The children develop their counting skills and squeal with delight when they find her hiding in the play tent.

The children benefit from being able to play in the large front and back gardens. They learn about growth through planting peas to eat and planting sunflowers seeds as part of a competition to see how tall they can grow. They develop physical skills through climbing on the play equipment and playing ball games, such as football. Children confidently ask the childminder to play in the garden on their favourite toys.

The childminder takes the children on regular outings to develop their social skills and confidence in larger groups. For example, they play alongside other children at toddler groups and in the library. She also takes them out to broaden their experiences, such as to see the cows at a local farm shop. The children enthusiastically recall their outings.

# What does the early years setting do well and what does it need to do better?

- The childminder develops children's independence very well. She patiently teaches children how to use zips on their lunch boxes and to put on their aprons when painting. Young children learn how to pour drinking water into cups and set the table with plates and bowls for snack time. Children are well prepared for the next stage in their learning.
- The childminder embeds mathematical development in all activities. Children learn about numbers and how to count with confidence. They play mathematics games where they learn about shapes and how to take turns. The childminder extends the children's knowledge in mathematics very well, such as when measuring quantities.
- The childminder provides a range of interesting activities in response to children's interests. For example, she works with the children to create cut-out characters from a favourite book to help retell the story. Young children become fully engaged in these activities and remain focused for long periods of time. However, the planning and implementation of other adult-led activities do not always build on what the children already know, and children sometimes lose focus.
- Children are very well behaved. They are extremely confident in the setting and



are able to express their likes and dislikes. The childminder teaches children about manners and praises them for using 'please' or 'thank you'. Her kind and gentle manner helps to promote good behaviour.

- The childminder promotes healthy lifestyles well. She asks parents to provide a healthy packed lunch and supports them with leaflets explaining how to do this. She promotes good hygiene through singing a special song with the children as they wash their hands. She encourages an active lifestyle and talks to them about how it makes their bodies feel. Children show excellent skills in independently balancing on equipment and completing fun obstacle courses. The childminder shows the children how to develop their ability when, for example, jumping into a hoop.
- Partnerships with parents are strong. They appreciate how 'incredibly kind' she is and that she puts a great deal of thought into the children's activities. The childminder communicates regularly with parents throughout the day. She also provides more formal updates on their child's achievements and next steps every term. Parents are fully informed of their children's progress.
- The childminder evaluates her own practice effectively. She has recently changed her recording systems, which has helped her to focus more sharply on children's next steps. In addition, she regularly provides parents with questionnaires and adapts her practice in response, if necessary. She attends local authority information meetings and is part of a network of local childminders, which supports her in keeping her knowledge up to date.

### Safeguarding

The arrangements for safeguarding are effective.

The childminder keeps up to date with safeguarding training. She ensures contact details for reporting concerns are up to date and accessible. She has a clear understanding of the signs and symptoms of abuse. The childminder carries out regular checks to ensure her home and garden are safe. She carries out monthly fire drills with the children and keeps a record of these. The childminder is highly vigilant when taking the children to busy places. She has robust procedures in place to prevent children from becoming lost, such as ensuring children wear wristbands with her contact details on in case of an emergency.

### What does the setting need to do to improve?

## To further improve the quality of the early years provision, the provider should:

adapt the planning and teaching of adult-led activities to build on the children's ability and previous experiences.
