Summary of key findings

This provision does not meet requirements

- The childminder has undertaken a basic life support training course focused on first aid for adults with some elements relating to children. However, she has not undertaken a full and relevant paediatric first-aid training course, which is a requirement of the early years foundation stage.
- The childminder does not have a secure knowledge of safeguarding. She understands the signs and symptoms of some types of abuse. However, she does not have a secure knowledge of female genital mutilation and radicalisation.
- The childminder has not considered the methods she will use to build effective relationships with staff in other settings that children attend.
- The childminder understands how to observe and assess children's development. She describes how she will use this information to help plan for children's next step in learning.
- The childminder has a dedicated playroom and a good range of resources. She outlines how she will use the resources to support children to progress in their learning and development.
- The childminder is able to describe how she will create a safe environment for children to play in. In addition, she thinks about risks on outings, such as strangers, and helps to reduce risks to children by taking actions, such as taking a first-aid box out with her.
- The childminder describes how she will make sure each child is included in her provision and she understands how to meet the individual needs of children.
- The childminder understands the importance of promoting good behaviour. She explains that she will teach children about expectations of their behaviour through games and activities, recognising and rewarding the things they do well.
- The childminder explains how she will build relationships with parents. She will gather information from parents when children first start to attend her setting and then work with them to create consistency between her setting and home.
- The childminder is committed to undertaking training to help her develop her knowledge. She understands how children learn and develop from gaining her level 3 qualification.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector viewed the resources and the areas of the premises that are used for childminding.
- The inspector discussed with the childminder how she intends to deliver the educational programmes for children.
- The childminder showed the inspector relevant documents.
