Summary of key findings

This provision meets requirements

- The leader understands his responsibilities to keep children safe and secure on the premises. Through discussion, he explains how staff would keep children safe when using the indoor and outside spaces.
- The leader recognises the importance of building and maintaining effective partnerships with parents. For instance, he would use parental feedback at the end of sessions to plan new holiday club activities and to improve the service for local families.
- The leader understands his safeguarding responsibilities to keep children safe from harm. He follows safeguarding procedures and know to refer his concerns to the designated safeguarding lead. Staff are expected to complete regular safeguarding training, including the 'Prevent' duty guidance, to help them understand their role in keeping children safe from radicalisation and extreme views.
- The leader explains how he would provide a range of high-quality, inclusive activities for all children. The leader works in partnership with the local city council and other agencies to provide holiday activities and food programmes for children in the local area. This would support children's personal development as they would learn about healthy eating and the importance of being physically active.
- Through discussion, the leader explains how staff support children's behaviour at this holiday club. For example, staff would talk to children about the expectations of behaviour at the beginning of the day. The leader explains the importance of children being successful in managing their behaviour and having respect for themselves and other people.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
