## Information about this children's home

This home provides care for up to 50 children. It is a privately owned residential special school that is also registered as a children's home. The home's statement of purpose states that children at this home have identified social, emotional and mental health needs. They may also have learning difficulties. The inspectors only inspected the social care provision at this school.

The manager registered with Ofsted in December 2020.

## This monitoring visit

During a full inspection on 15 and 16 November 2022, inspectors identified significant shortfalls in safeguarding practice and leadership and management. As a result, two compliance notices were issued under Section 22a of the Care Standards Act. These related to 12 (the protection of children standard) and regulation 13 (the leadership and management standard).

The focus of this visit was to monitor and review the actions taken by the provider to meet the compliance notice relating to regulation 12.

Children now benefit from individualised risk management plans. Staff have taken effective action in response to incidents because the plans provide them with clear strategies to follow to reduce risks for children. The plans are regularly reviewed and shared with staff to ensure that they have the most current information in relation to children's risks and any vulnerabilities.

Staff have benefited from training to improve their skills and knowledge. As a result, safeguarding practice has improved. Key policies have been reviewed alongside revised formats for team meetings and development days. Staff are encouraged to



reflect on safeguarding incidents and are provided with learning opportunities to further develop their practice.

Staff have completed numerous training courses since the last inspection. Leaders and managers ensure that training is effective by evaluating the impact on staff practice.

There is now regular and effective communication between all staff. Any concerns are reported in a timely way, which ensures that there is a multi-disciplinary approach to managing children's risks and vulnerabilities.

In Ofsted's view, the provider has taken sufficient action to meet the compliance notice under 12.

#### Recommendation

The registered person should ensure that all staff have their performance and fitness to carry out their role formally appraised at least once annually. This appraisal should consider, where reasonable and practical, the views of other professionals who have worked with the staff member over the year and children in the home's care.
