Summary of key findings

This provision meets requirements

- Since the last inspection, the provider has developed a clear plan for the professional development of staff. He is committed to ensure staff receive the training, coaching and support they need to fulfil their roles, such as through regular appraisals and monthly meetings.
- The provider explains staff continuously reflect on the interests of children and plan a range of activities based around their individual needs and preferences. The site supervisor and staff demonstrate, through discussion, how they ensure resources are accessible to allow children to make independent choices and lead their own play. They explain how they provide an inclusive environment to ensure all children benefit from the activities they provide.
- The provider ensures robust procedures are in place for administering medicines. For example, he describes the permission forms that parents need to complete, and the information staff need to record and share with parents, should they need to administer medication to children.
- The provider discusses how he ensures the site supervisor deploys staff effectively to ensure children's safety. He explains how staff talk to children about how they can keep themselves safe. There are clear procedures in place if a member of staff has concerns about the welfare of a child. The provider demonstrates a robust understanding of the actions to take should staff raise any concerns.
- The provider has a good understanding of how to promote children's health and well-being. Staff explain how they provide children with a variety of healthy snacks after their school day, and a nutritious tea later on in the session. They talk about the outdoor activities children have opportunities to take part in, such as hockey.
- The provider recognises the importance of positive partnership working with teachers at the school. He highlights strategies, such as digital media, to ensure a two-way flow of information between the club and parents. This helps to ensure consistency in children's care and well-being.
- The provider discusses the high expectations that he has for children's behaviour. He demonstrates a good understanding of the importance of consistent approaches to behaviour management. The site supervisor talks about maintaining positive communication with parents and the school to ensure that staff mirror successful strategies to support children. He describes how they ensure children have opportunities to relax and unwind in comfortable spaces.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed the impact of the pandemic with the provider and has taken this into account in their evaluation of the provider.
- The inspector talked to the provider and staff about the range of activities they provide for children, both indoors and outdoors.
- The provider discussed his expectations for children's behaviour while attending the club.
- The inspector sampled a range of documentation, including the suitability of staff, paediatric first-aid certificate and public liability insurance.
- The inspector asked staff questions throughout the inspection to establish their understanding of how to safeguard children.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
