What is it like to attend this early years setting?

The provision is inadequate

Children's health, safety and well-being are at significant and immediate risk. There are fundamental weaknesses in the running of the setting. A catalogue of management failures has meant that children are receiving an unacceptable level of care and education. Because of this, the provider's registration was suspended during the inspection. The majority of staff, including the manager, work unsupervised with children without having their suitability confirmed. A lack of induction and ongoing supervision means that staff have significant gaps in their skills and knowledge and are unable to fulfil their roles. The manager and staff do not know enough about children to keep them safe. They fail to meet children's care and learning needs, or support children's behaviour in an appropriate way. None of the staff can confidently access an online database containing vital information about children, such as medical and dietary information. This puts children at risk.

Children are cared for in a dangerous and unhygienic environment. Fire safety requirements are not met. Children are exposed to hazards, both inside and outside. Because of the unsafe outdoor area, babies and toddlers are denied daily outdoor activity. They are deprived of fresh air and exercise to promote their good health and physical development. Sleeping arrangements are not safe. Toilet and nappy changing facilities are not clean and are unsanitary. Children are cared for by unfamiliar new staff. This has a negative impact on their well-being. For example, babies cry continually and show they are anxious and stressed. They do not have secure attachments with the staff who are caring for them.

What does the early years setting do well and what does it need to do better?

- Catastrophic failings in the leadership and management of this setting have resulted in a multitude of breaches in statutory requirements. No improvement has been made since Ofsted's recent regulatory involvement. A robust recruitment procedure has not been followed. The provider has not confirmed the suitability of the newly appointed manager and staff, of which there are many. Staff work unsupervised with children without being subject to essential vetting processes, such as disclosure and barring service checks.
- The provider has failed to give the new manager and staff a thorough induction. This means that they do not know how to fulfil their role or have a clear understanding of how to keep children safe. They cannot access vital information about children's care needs because they do not know how to operate the online database where this is stored. Existing staff have not received appropriate and effective performance management. Therefore, weaknesses in staff's practice and a decline in staff well-being have gone unnoticed.
- Secure child protection measures are not in place. Arrangements for the care of



- looked after children are unknown by staff and the manager. Furthermore, the manager and staff lack vital information about children's lives at home to adequately safeguard them.
- Staff do not know enough about children's individual learning needs or child development to provide an appropriate curriculum. The provider has instructed staff to restrain children, who have emerging special educational needs and/or disabilities, into highchairs to prevent them from exploring their environment at times throughout the day. Overall, children are not learning at a rate which they are capable of.
- Staff do not know about children's medical needs or the procedure for administering medication. Staff report they have recently found medication in children's bags that they have been unaware of, and they do not know when or how to administer it. Staff are confused about children's dietary requirements. Those involved in food preparation do not have correct information about children's allergies. This puts children at risk of a medical emergency through reacting to unsuitable food.
- The provider does not ensure the premises is safe and secure. Fire safety requirements are not met. Staff do not know how to safely evacuate children from the building in the event of an emergency. Furthermore, unauthorised people could enter the premises through an open gate into the garden area.
- Staff do not risk assess the environment in which children play. Children are exposed to a multitude of hazards. For example, cleaning products and nappy bags are stored in easy reach of children. Outside, the play environment is neither safe nor inviting for children. Litter and garden waste are not removed. Because of this, staff do not provide babies and younger children with daily opportunities to play outside.
- Staff do not know the latest safety guidance for when children sleep. Babies and young children sleep in unsuitable equipment. For example, older babies sleep slouched in threadbare baby bouncers. Nappy changing facilities are not clean or sanitary. Toddlers and pre-school children use unhygienic toilet facilities. Unidentifiable liquid leaks from toilets and potties are stained with dried urine.
- The provider has not made sure an effective key-person system is operating. Parents do not know their child's key person. They are not kept informed about staff changes and information about their child is not consistently exchanged. Some children's well-being is severely compromised because they have no bonds with those looking after them. As a result, some babies cry for long periods of time. They appear stressed and are observed to physically harm themselves by scratching their necks.
- During the inspection, some records which were requested were neither available nor easily accessible. The manager and deputy manager lack an abundance of essential information that they need to adequately run the setting.

Safeguarding

The arrangements for safeguarding are not effective.

Children are not safe at this setting and therefore the provider's registration has



been suspended. The manager and staff do not know important information about children to effectively safeguard them. Procedures to safeguard children are flawed. Staff do not know about children's health or care needs. The premises, environment and equipment are neither safe nor suitable for children. Children are exposed to risks that are not addressed by staff, which compromise their health, safety and welfare. The provider does not follow safe recruitment processes. The manager and numerous staff are working without having their suitability to fulfil their roles being confirmed.

What does the setting need to do to improve?

The provision is inadequate and Ofsted intends to take enforcement action.

Information about this early years setting

Wollaton Village Day Nursery registered in 2000 and is located in Eastwood Village, Nottinghamshire. The nursery employs 13 members of childcare staff. Of these, eight hold appropriate early years qualifications at level 3, and three at level 2. The nursery opens from Monday to Friday, all year round, except for bank holidays. Sessions are from 7.30am until 6pm. The nursery provides funded early education for two-, three- and four-year-old children.

Inspection activities

- This was the first routine inspection the provider received since the COVID-19 pandemic began. The inspectors discussed the impact of the pandemic with the provider and have taken that into account in their evaluation of the provider.
- We carried out this inspection as a result of a risk assessment, following information we received about the provider.
- The inspectors viewed the provision and discussed the safety and suitability of the premises.
- The manager joined the inspectors on a learning walk and talked to the inspectors about their curriculum and what they want their children to learn.
- The inspectors talked to staff at appropriate times during the inspection and took account of their views.
- The inspectors observed the quality of education being provided, indoors and outdoors, and assessed the impact that this was having on children's learning.
- One inspector carried out a joint observation of a painting activity with the manager.
- The inspectors spoke to several parents during the inspection, read an email from a parent and took account of their views.
- The inspectors looked at relevant documentation and reviewed evidence of the suitability of staff working in the nursery.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
