Information about this children's home

The home is part of an independent children's therapeutic community which is accredited by the Royal College of Psychiatrists. It provides care for up to five children who experience social and emotional difficulties.

The manager has been in post since November 2022.

Information about this inspection

At this inspection, the inspector evaluated:

- the care of children
- the safety of children
- the effectiveness of leaders and managers.

Inspectors have looked closely at the experiences and progress of children, using the social care common inspection framework. This assurance inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with the Children's Homes (England) Regulations 2015 and the 'Guide to the Children's Homes Regulations, including the quality standards'.

Findings from the inspection

We did not identify any serious or widespread concerns in relation to the care or protection of children at this assurance inspection.

The care of children

Children have positive relationships with the staff, who nurture and care for them. There is a consistent staff team in place, and children said they can talk to staff if they are worried. Children's achievements are proudly recognised and celebrated with staff.

Children have individual link workers who they meet with regularly. These meetings are individual to the child's needs, where they can talk about their behaviour, health needs, goals and their future. There are additional opportunities for children to receive therapeutic support through one-to-one sessions with the registered manager, who is a qualified therapist.

Children's experiences are enhanced by living at the home. Children receive wellplanned care from staff who know their plans well. They enjoy a wide range of activities with staff; treasure hunts are a favourite.

Children can personalise their bedrooms and the decor reflects what they like. Children were proud to show the inspector certificates displayed on their bedroom walls. However, some other areas of the home require a tidy, refresh and repair. For example, some areas of the home were cluttered, some furniture needs replacing and some walls need painting.

The safety of children

Children are safeguarded. Incidents involving children are well managed, with clear recording systems. For example, a chronology log details incidents and consequences, which children have opportunities to reflect on. This record also shows the reduction in physical interventions and the focus on achievements.

Concerns are managed effectively and are taken seriously by senior leaders. However, the home's records do not include a factual description of incidents and advice has not been sought from external professionals before the manager has concluded their review of the event.

Staff receive training specific to the needs of the children in the home and understand their safeguarding responsibilities. Children are kept safe from harm.

Leaders and managers have worked with the local authority designated officer and a child's social worker to support a detailed plan in relation to allegations that have been made. This demonstrates good partnership working, ensuring that all



safeguarding concerns are audited and examined to ensure that processes keep children safe.

The effectiveness of leaders and managers

Leaders and managers have responded effectively to the previous requirements. They have taken action to address a previous shortfall, by making sure that allegations raised by children are promptly reported to Ofsted and the local authority designated officer.

The recently appointed home manager has a good overview of records completed by staff and makes recommendations to improve practice with the team. This is also discussed in supervision with staff, which gives them the opportunity to develop their skills.

Leaders and managers have a good understanding of the strengths and weaknesses of the home and understand the needs of the children. There are effective monitoring systems in place. Consequently, the management team has good oversight of children's day-to-day experiences and the progress that children make.

What does the children's home need to do to improve? Recommendations

- The registered person should ensure that the home's record of regulation 40 events includes a factual description of the serious event, the action taken and the outcome of any resulting investigation. This is in relation to emotive language in reporting, and decisions to conclude investigations into serious events before seeking advice. ('Guide to the Children's Homes Regulations, including the quality standards', page 63, paragraph 14.14)
- The registered person should provide a children's home that is a nurturing and supportive environment that meets the needs of their children. Children's homes must comply with relevant health and safety legislations; however, in doing so, homes should seek as far as possible to maintain a domestic impression. This is in relation to the front of the home, redecoration and keeping the home free from clutter. ('Guide to the Children's Homes Regulations, including the quality standards', page 15, paragraph 3.9)
