## **Inspection judgements**

#### Overall experiences and progress of children and young people: good

The home is decorated to a high standard. The colours of the walls are vibrant, giving the home an appealing quality. Pictures of children's family are hung in the main living area, providing a real sense that this is somewhere that they can feel settled. Children's rooms are personalised and decorated to their taste. Carers have been valiant in their efforts to ensure that all rooms are homely for children. The outdoor space provides opportunities for children to undertake activities, making the most of the beautiful rural setting.

Children who live in the home are loved and well cared for. Carers talk about children with familiarity. They have a good knowledge of the children's needs and how to meet them. This feeds into well-written plans.

Support provided to children who are preparing for adulthood is a strength of the home. Since the last inspection, one child has moved on to live independently. Carers are currently supporting one child to develop vital skills in preparation for leaving the home. Plans to support children towards independence are thorough and clearly presented, with the knowledge that the child will be accessing them. Achievements and next steps are clearly identified and are individualised to the child's needs. Conversations with children are focused and nurturing.

Concerns in relation to children's health are managed well. Where a child has been smoking and vaping, carers have sought professional guidance and support. Educational conversations take place, with the aim that the child will cease the harmful behaviour. The child takes prescribed medication to support them to cease smoking. Staff support the child to self-medicate in line with the child's age and plan to promote independence skills.

Children's cultural and identity needs are supported. When children wish to attend church, this is seen as an essential part of their schedule. When children spend time with their family, carers work hard to make these positive experiences for children. One parent likened staff to family members and rated the care provide to their child as 'outstanding'.

#### How well children and young people are helped and protected: good

One child expressed that they like living in the home. They told the inspector that they feel safe, have positive relationships with all carers, and receive excellent care. Observations of the child with carers evidenced the quality of their relationships.

Risk is effectively assessed and managed. Where risk is identified, the home works to formulate good-quality plans. Carers communicate with professionals and family to identify and manage risk. A sensitive approach is taken when addressing risk with children. This will allow them to reflect on their actions and provide learning and



guidance. Risk assessments contain essential information and helpfully contain photographs that support staff to identify locations of concern.

There are few incidents in the home. When these do happen, good-quality recordings are completed. Relevant professionals and family members are informed and debriefs are completed with children. Meetings with professionals are requested, where appropriate. Reflective conversations take place with children and action is taken in relation to any concerns.

Children are provided with the care and support that they require. Three professionals spoke positively to the inspector about carers' practice. Strengths of the home were identified as communication, highlighting and managing risk, and going to great lengths to meet the overall needs of children.

Concerns in relation to staff practice are dealt with efficiently. When deficits in carers' knowledge and practice are identified, training is promptly identified and commissioned to allow that carer to improve their skill set.

#### The effectiveness of leaders and managers: good

The registered manager is passionate about children. They want children to thrive and achieve. They know the children who live in the home well. The manager speaks about the child with warmth and clearly advocates for what they believed was in the child's best interests.

Leaders and managers effectively challenge concerns in relation to care plans. A court-directed care package for one child has meant that carers have not been able to provide the child with the level of care that they felt was required. As a result, the child has not been able to benefit from all that the home has to offer and will be moving on from the home.

Team meetings take place regularly. There is a clear focus on the child and their care needs. Actions identified during team meetings are not clearly recorded in the written records. They do not detail who should complete the action and there are no dates for the completion of actions. The documents do not support staff or management to monitor progress.

Carers feel supported by the management team. They spoke of positive experiences of supervision. Carers spoke positively about the support provided by the management team. Supervision takes place regularly, is reflective, focuses the well-being of carers, and considers their practice and learning needs.

Recruitment practice is of a good standard. All required checks are carried out before staff are employed. Where concerns are identified during the recruitment process, robust risk assessments are completed. The home employs an adequate



number of staff to meet the needs of the children currently living in the home. Agency staff are not used.
