Summary of key findings

This provision meets requirements

- The area manager explains how the provider will recruit staff and ensure that they are suitable to work with children. A thorough induction procedure will help new staff have the knowledge and ability to care for children and to support their safety. Thereafter, staff will be invited to attend supervision meetings to discuss and review their practice.
- The area manager understands how to identify the signs and symptoms that may suggest a child is at risk of harm, radicalisation or extreme views. She knows where to report concerns about children's safety or if an allegation of abuse is made against a member of staff. Furthermore, she explains how she will ensure that staff's knowledge of safeguarding is current.
- The area manager explains how she will support staff to manage children's behaviour. For example, she will encourage staff and children to create rules and boundaries in the club. She intends to support staff to give children positive praise for their achievements. The area manager plans for staff to work with teachers at the host school to provide consistency in managing children's individual behavioural needs.
- The area manager plans to help staff to work in partnership with parents. She intends for staff to speak to parents about activities children enjoy in the club. Parents will have access to photos that will enable them to see their children's experiences. The club's policies and procedures will be available for parents to view.
- The area manager explains how she intends to complement the learning children receive in school. For example, staff will talk to children to help them remember what they are learning during their day at school. They will encourage children to read books and to write their name.
- The area manager explains how children's independence will be promoted in the club. For example, she intends to encourage staff to let children complete tasks on their own. This will include asking children to wash their hands after playing outdoors, using the toilet and before they eat.
- The area manager intends to offer children healthy snacks and drinks to help promote children's good health. She intends to ensure that children have opportunities to play outdoors every day. The area manager intends to offer children plenty of opportunities to bake and to understand where foods come from and the different ingredients in foods.
- The area manager understands the importance of involving children in making decisions in the club. This will include asking children about their interests, so staff can provide activities and resources that they know children enjoy.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- This was the first routine inspection the provider has received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the provider and has taken that into account in their evaluation of the provider.
- The inspector and area manager had a tour of the areas of the premises used by children and discussed the equipment and toys available.
- The inspector held discussions with the area manager. She reviewed a sample of documentation, such as policies and procedures.
- The inspector discussed the safeguarding and welfare requirements with the area manager.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
