Inspection judgements

Overall experiences and progress of children and young people: good

Children have lived in this home for varying lengths of time and have made progress in line with their individual experiences. One parent said, 'My child's life is back on track after living at the home. She has changed so much; she can now make safe choices.'

The quality of care provided to the children helps them to make progress and achieve their outcomes. Staff use the principles of therapeutic care in the delivery of their support and guidance to the children. Children engage with staff who help them to understand how their decisions and life choices impact on their safety and well-being. The manager's review of the children's records provides the children with a written, empathetic message of further support.

Children have experienced unplanned moves out of this home in response to their emerging risk and needs. Children may need help to understand the reason for this change and recognise their experiences and the progress they made while living at the home. One child has received a therapeutic letter from the clinical team to highlight their therapy journey. However, this is not a letter that all children currently receive. The manager understands how change affects children, and children are again experiencing a settled period in the home.

Children's education arrangements vary as the children find the characteristics of an educational environment difficult. The manager, with her team, works in partnership with educational professionals to remove potential barriers to the children's learning. Education plans are created to try and meet each child's needs and reduce the pressure from peers. However, one current plan does not support the child to achieve their objectives and full potential.

The staff have helped children to re-establish family relationships and build crucial links and support systems for when they leave the home.

Extensive damage had been caused to the home. There is evidence of redecoration and refurbishment to return the state of the home back to its former high standard. However, further maintenance and repair are necessary, particularly to the kitchen cupboards and the home's carpets.

How well children and young people are helped and protected: good

Previously, children did not go missing from the home. However, recently, children have been reported as missing from home, which increases their risk of harm. Staff are proactive in their responses to missing-from-home incidents. The staff will carry out widespread searches and implement disruption techniques to aid in the quick and safe return of children. Any identified shortfalls in staff responses have been addressed by the manager. However, the children's risk assessments need to



consistently provide accurate information about local towns that are assessed as either safe or unsafe.

The staff help the children to understand and recognise child exploitation as abuse. As children build their confidence, there is a reduction of guilt, and children start to recognise risk. While children develop their ability to make safe choices, things that increase their risk of exploitation are restricted, for example social media. Door alarms are also fitted to the children's bedroom doors. This system alerts staff of children's movement. This monitoring is persistent, as alarm settings are not adjusted in response to the child's risk or staff presence.

The group dynamic has recently been a trigger for incidents. The staff have not had the confidence or resilience to consistently curb children's heightened emotional states. The manager addressed the staff about their over-reliance on calling the police. However, no arrests or charges were made against the children. The clinical team has supported the development of practice learning and implements care strategies to improve the outcomes for children.

The effectiveness of leaders and managers: requires improvement to be good

Until January 2023, a confident and experienced manager consistently led the home. Since they left, the provider has taken measures to fill their role, and an acting manager is leading the team. However, Ofsted has not received an application for the registration of the manager.

Formal supervision sessions provide staff with protected time for learning and practice reflection. Staff can confidently raise questions and gain clarity about practice and procedures, linking these to specific children. However, the quality of supervision sessions and staff debriefs can vary greatly depending on the supervisor. This quality needs to be consistently good to ensure that staff value the supervision process and practice is celebrated and developed.

Forming trusted relationships with staff can be difficult for children, and there has been a high turnaround of staff. Newly appointed staff have limited experience in children's residential care, and the provider has needed to review its approaches to the recruitment and induction process. Staff are being supported to learn and build the skills necessary for their role, which was evident when the inspector spoke to a newly recruited staff member.

Appointed staff are subject to safer recruitment checks. Applicants are expected to provide a full and accurate employment history, including detailing the reasons for leaving their previous employment. However, any identified gaps in staff's employment history are not accurately recorded or reviewed.

The manager has internal and external monitoring systems in place to improve the quality of the care that children receive. The external monitoring of the home is undertaken regularly to provide support to the manager in the identification of



practice strengths and developments. However, the consultation within these reports can be limited, and this impacts on the independent person's ability to form their opinion about the welfare of children.

Recommendations

■ The registered person should actively seek independent scrutiny of the home to ensure continuous improvement. These compiled external monitoring reports should include consultation to aid the independent person to form their opinion



about the welfare and protection of children. ('Guide to the Children's Homes Regulations, including the quality standards', page 55, paragraph 10.24)

- The registered person should ensure that any use of monitoring equipment in the form of bedroom door alarms is routinely reviewed. The evaluation of the use of door alarms should detail how this measure supports the safeguarding and wellbeing of those living and working in the home, and the routine use throughout the day. ('Guide to the Children's Homes Regulations, including the quality standards', page 16, paragraph 3.16)
- The registered person should ensure that staff supervision consistently enables staff to reflect on their practice and how this affects the children they care for. ('Guide to the Children's Homes Regulations, including the quality standards', page 39, paragraph 8.15)
- The registered person should ensure that the current plan of redecoration and refurbishment of the home continues and the children's home is a nurturing and homely environment. ('Guide to the Children's Homes Regulations, including the quality standards', page 15, paragraph 3.9)
- The registered person should ensure that staff continually and actively assess the risks to each child, and the arrangements in place to protect them should be recorded within each child's risk assessment plan. ('Guide to the Children's Homes Regulations, including the quality standards', page 42, paragraph 9.5)
- The registered person should ensure that when a child's transition is unplanned, there is opportunity for children to understand the progress and experiences they gained while living at the home. ('Guide to the Children's Homes Regulations, including the quality standards', page 57, paragraph 11.9)
