Summary of key findings

This provision does not meet requirements

- The childminder does not meet all the requirements of the early years foundation stage and Childcare Register. She does not ensure that she holds a full current paediatric first-aid certificate.
- The childminder does not ensure that appropriate public liability insurance is in place, which is a breach of statutory requirements.
- The childminder does not demonstrate an understanding of the information required to be recorded for each child in her care. She does not ensure that this information is maintained and easily accessible and contains all required information, such as their full name, date of birth, name and address of every parent and/or carer and emergency contact details for parents and/or carers.
- The childminder does not understand the requirement to maintain a daily record of the names of all children being cared for and their hours of attendance, whether it is for a short or long term.
- The childminder has improved her knowledge and understanding of what must be notified to Ofsted. She knows when and how to supply the required information to Ofsted. The childminder has also improved her knowledge about the recruitment procedures to be followed, to ensure that those living or working on the premises are suitable before they are allowed to be left alone with children.
- The childminder demonstrates an appropriate knowledge and understanding of how children learn and develop. She describes how she will organise a variety of interesting activities that cover all areas of learning to extend children's interests, skills and abilities.
- The childminder understands how to manage children's behaviour appropriately. She values the importance of working in partnership with parents to maintain consistency.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:
