# **Inspection judgements**

#### Overall experiences and progress of children and young people: good

The children living in this home are making good progress. The effective contact between staff and school is helping to improve the children's school attendance. Staff support children to learn and have future aspirations, which has resulted in children becoming more interested in their education and motivated to learn.

Children and staff form positive relationships. A schoolteacher said:

'Our student was very unsettled in their previous temporary foster home. As soon as the child moved into this home, they were able to build trusted/secure relationships and seemed much happier there.'

Children's records are comprehensive and reflect their needs. Children's care plans are child focused, which makes them more meaningful for each child.

Children enjoy a range of activities in the community and in the home. As well as going out with their friends, the children participate in various activities in the home, such as hair braiding, cooking and baking.

Children know how to make a complaint. Their complaints are swiftly managed, which makes the children feel valued and listened to.

The home provides a warm and nurturing environment for the children. Children's bedrooms are personalised and suitably furnished. However, the use of monitoring and surveillance devices detracts from a homely environment.

#### How well children and young people are helped and protected: good

Staff know and understand children's risks and vulnerabilities and implement effective strategies to mitigate risk. Children's safety is enhanced through effective communication with the child's professional network and external agencies about safeguarding issues. The manager and staff are proactive in ensuring that independent return home interviews take place when children return from being missing from home.

Staff are proactive in helping and protecting children. They have a clear understanding of safeguarding practices and the whistle-blowing policy. Their ability to keep children safe is enhanced through meaningful discussions with children about issues such as substance misuse, missing-from-home incidents and their emotional and physical well-being.

The stable, skilled and consistent staff team enhances children's safety and wellbeing. Staff recruitment processes are thorough, which ensures that the staff are suitable to care for children.



Room searches are carried out when necessary to help to keep children safe. Room search records demonstrate that staff follow the correct procedures, and the rationale for room searches is justified and clear.

#### The effectiveness of leaders and managers: good

Leaders and managers have high aspirations for children and high expectations for the home. The manager regularly reviews children's progress through staff supervision, team meetings and discussions with children.

If children are not settling into the home, the manager takes action to ensure that there is a prompt review of children's plans. The manager and staff work proactively with other professionals to support children to settle in the home. If children are unable to settle and it is in their best interests to move from the home, plans to move them on are sensitively managed.

Children live in a supportive environment. The manager and staff benefit from the support of a psychologist, who helps them to understand the children's behaviour and needs. This helps staff to improve the quality of care provided to children.

Staff receive regular and effective supervision. Supervision focuses on children's needs, experiences and plans. Safeguarding issues are discussed, as well as staff development needs. This ensures that managers have effective oversight of the progress children make and staff practice. However, supervision records are not available for all staff. This limits the manager's oversight of staff development and practice.
