The provider states within the statement of purpose that this home provides longterm placements for up to three children aged between 11 and 18 years. These children may have autism spectrum disorder and/or associated conditions.

# This monitoring visit

A monitoring visit was completed due to uncertainties about the financial stability of the home and the potential impact this could have on the staff team and consequently, the child. In addition, a complaint was received by Ofsted, regarding the standards of care provided at the home. During this visit, no concerns were identified about the child's care.

There is a core staff team who are committed to the child's welfare. During this visit no significant concerns were identified regarding the care provided to the child. He has thrived under the nurture of the manager and her team.

This child was previously tube fed to ensure he was receiving the nutrition he needed. He is now eating a varied diet which is tremendous progress. He was also on a high level of behavioural support medication when he arrived at the home. He no longer needs this type of medication. There have been no incidents in many months.

This child is now enjoying, shopping, swimming, surfing, and many other activities. He is happy and well cared for.

Ofsted will continue to closely monitor the situation at this home to ensure that the child continues to receive good care.

## **Statutory requirements**

Requirement	Due date
The registered person must ensure that—	4 May 2023
within 48 hours of the use of the measure, the registered person, or a person who is authorised by the registered person to do so ("the authorised person")—	
has spoken to the user about the measure; and	
has signed the record to confirm it is accurate; and	
within 5 days of the use of the measure, the registered person or the authorised person adds to the record confirmation that they have spoken to the child about the measure. (Regulation 35 (3)(b)(i)(ii)(c))	
The requirements are that—	4 May 2023
the individual has the appropriate experience, qualification and skills for the work that the individual is to perform.	
For the purposes of paragraph (3)(b), an individual who works in the home in a care role has the appropriate qualification if, by the relevant date, the individual has attained—	
the Level 3 Diploma for Residential Childcare (England) ("the Level 3 Diploma"); or	
a qualification which the registered person considers to be equivalent to the Level 3 Diploma.	
The relevant date is—	
in the case of an individual who starts working in a care role in a home after 1st April 2014, the date which falls 2 years after the date on which the individual started working in a care role in a home. (Regulation 32 (3)(b) (4)(a)(b) (5)(a))	



In particular, the manager must ensure that they complete the required qualifications for their role without further delay.

The registered person should ensure that the home's statement of purpose accurately reflects the arrangements for professional supervision for all staff. ('Guide to the Children's Homes Regulations, including the quality standards', page 53, paragraph 10.10)
