## Information about this children's home

A private company operates this children's home. It is registered to provide care for three children with learning disabilities.

There has been no registered manager in post since June 2022.

Inspection date: 28 April 2023

## This monitoring visit

This monitoring visit was undertaken to review whether the provider has complied with the suspension notice imposed by Ofsted on 22 March 2023. On 21 March 2023 Ofsted were provided information anonymously, concerns were shared that a child and an adult were living in the children's home. Furthermore, it was alleged that alcohol and drugs were being consumed on the premises. At that visit inspectors found that poor oversight from leaders and the independent person had enabled the home to be used in an unfit manner. The responsible individual had been unaware the home was being used by the contractor to live in and arranged for the contractors and child to leave the site.

At this visit the home was vacant. No children were residing at the home, and no staff were present. The previous contractors were not present, and the home does not smell of cannabis. The suspension notice has been complied with.

The home remains unhabitable, and renovations have stalled. The organisation is awaiting new contractors to complete the work required.

The responsible individual has stated the home is not anticipated to be used before November 2023. There continues to be no staff team and no manager has been appointed therefore the organisation can not offer care to children at present.

Ofsted will continue to monitor the suspension; this will remain effective until 14 June 2023.

is not, or does not intend to be, in day-to-day charge of the home.	



If the registered provider appoints a person to manage the home, the registered provider must, without delay, give HMCI notice of the name of the person so appointed; and the date on which the appointment takes effect. (Regulation 27 (1)(a)(b)(i)(ii)(2)(a)(b))
