# Overall experiences and progress of children and young people: requires improvement to be good

At the time of the inspection, one child was living in the home. The child has made some progress since the last inspection. When staff are able to engage the child, the child has positive experiences. However, staff have not been able to do this consistently and the child has spent significant periods of time not engaging in meaningful activities. This limits the child's progress.

The child benefits from living in a warm, welcoming and homely environment. They spend time with staff relaxing in the home. The child has contributed to the decoration of the home, with the games room being personalised to reflect their individuality and interests.

External professionals are complimentary about the care given to the child and the relationships they have developed with staff. The child's social worker said, '[Name of child] has built relationships with many of the staff members.'

The staff team has actively supported the child to pursue their interests. The child now goes to a local youth club, uses the home gym and plays sports. This supports the child to develop their social skills and promotes their health and well-being.

The inspector spoke to the child about their experiences of living in the home. The child says they are happy at the home and that they feel supported by staff. The child said, 'Yes, everything is good, I have no worries.'

# How well children and young people are helped and protected: requires improvement to be good

There has been a significant reduction of serious incidents in and out of the home since the last inspection. Staff said that as a result of this, they have been able to spend more time on training. Consequently, staff say they are more confident in their ability to manage conflict and prevent situations escalating.

The child said they feel happy and safe at the home. They said they feel confident in being able to share any concerns with staff and that they have been told how to make a complaint if needed.

When the child goes missing from home, there is a clear and consistent response from the staff. Staff search for the child and report them missing to police. Following the child's return, a return home interview is undertaken and staff carry out direct work with the child to try and reduce risks in the future. This reinforces to the child that they have people in their lives who care about them and want to keep them safe.



Staff undertake direct work with the child in line with emerging risks. Staff are provided with guidance on steps to take to manage risk. However, the quality of the recording in documents that are important for the child is inconsistent. Some have not been updated to include current information around managing risk and some include multiple spelling mistakes. This makes key documentation for the child unclear when they read their records now or in the future.

# The effectiveness of leaders and managers: requires improvement to be good

The home's manager has been in post since October 2022. However, the manager has still not applied to register with Ofsted as required by regulation. This means that the regulator has been unable to assess the suitability of the manager.

The manager, responsible individual and assistant manager have made numerous improvements to the care provided. The level of management oversight has improved, with the responsible individual undertaking monthly quality assurance audits. These audits inform the improvement plan.

Staff say they feel supported by the manager. One staff member talked positively about the changes made in recent months, saying, 'My confidence previously was rock bottom. However, the manager has really tried and we are coming together now more and more as a team and it is working well.'

Staff engagement in training has significantly improved since the last inspection. Staff have been able to access a variety of training, such as on behaviour management, conflict management, trauma and attachment. As a result, staff say they feel more confident and able to meet the needs of the child.

Staff team meetings are well attended and include guest speakers. Meetings focus on the needs of the child, staff development and reflection on practice. This has helped boost team morale in the home.

#### Recommendation

■ The registered person should ensure that staff record information on individual children in a non-stigmatising way that distinguishes between fact, opinion and third-party information. Information about the child must always be recorded in a way that will be helpful to the child. ('Guide to the Children's Homes Regulations, including the quality standards', page 62, paragraph 14.4)
