Summary of key findings

This provision does not meet requirements

- The childminder does not have a secure understanding of child protection issues. Although she has a comprehensive safeguarding policy that includes information about the 'Prevent' duty and female genital mutilation, she is unsure how to identify children who may be at risk.
- The childminder's knowledge and understanding of notifying Ofsted of significant events that affect her suitability to care for young children is weak. The provider did not notify Ofsted of an important matter within the required timescales.
- The childminder's knowledge and understanding of how to assess children's progress and development is weak. The childminder also lacks knowledge of the requirement to record and share progress checks for children aged between two and three years with parents and relevant professionals.
- The childminder understands the importance of children having a varied and challenging curriculum. She describes how she uses children's interests to encourage and engage them in their learning. The childminder understands the importance of promoting children's language and communication skills.
- The childminder provides a safe and welcoming environment with ageappropriate resources and toys. She explains how she will help children to feel reassured, confident and settled in her care.
- The childminder understands how to reflect on the quality of her practice to identify areas for further development. She recognises the need to continue to improve her skills and knowledge.
- The childminder knows the importance of carrying out risk assessments. She describes how she will identify and remove any possible hazards in her home and when she takes children on outings.
- The childminder understands the benefits of working closely with parents and other settings children may attend to promote continuity of children's care and learning.
- The childminder understands how to promote positive behaviour with children in order to support and develop their confidence and self-esteem. She knows how to support children to develop respect for others different to themselves.
- The childminder understands the importance of promoting children's physical development and a healthy lifestyle, and support their growing independence. Through discussion, she demonstrates how she intends to provide daily opportunities for children to play in the garden and visit local parks to enjoy fresh air and exercise.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?

To meet the requirements of the early years foundation stage and Childcare Register the provider must:

Inspection activities

- This was the first routine inspection the childminder received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the childminder and has taken that into account in their evaluation of the provider.
- The childminder and the inspector discussed how the childminder organises her early years provision, including the rationale for her early years foundation stage curriculum, and how she will monitor and plan for children's individual needs.
- The inspector sampled a range of documents and discussed the records and policies the childminder uses for childminding.
- The inspector discussed with the childminder her understanding of how to keep children safe.
- The inspector discussed the evaluations that the childminder uses to plan for improvements.



We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
