Inspection judgements

Overall experiences and progress of children and young people: requires improvement to be good

Staff form good relationships with children; however, children's experiences and progress have been mixed. Leaders and managers have failed to appropriately escalate concerns about one child's education provision in a timely manner. Opportunities for the child to develop positive social and educational outcomes have therefore been missed.

The oversight of the physical environment of the home does not pick up health and safety issues effectively. Systems in place are ineffective in ensuring that the quality of living standards for children is good. Poor environmental conditions have the potential to negatively affect the children's physical and mental health.

Children's health needs are well promoted by staff. Staff encourage children to have meals together. They educate children about healthy meal options and nutritious food choices. In addition, staff support children to attend medical appointments when required, which helps them to remain healthy.

Children enjoy participating in a variety of social activities. Some children enjoy swimming and going for walks. Others love listening to music and taking part in other activities in the home. Staff ensure that they take photos of these occasions to build positive memories for children of their time living in the home.

Children are supported to see their families. This ensures that children maintain family ties and positive relationships. As a result, children do not feel isolated from the people who are important to them.

How well children and young people are helped and protected: requires improvement to be good

Risk assessments do not always capture all the information known about children. As a result, plans to mitigate risk do not sufficiently guide and inform staff on how to manage and reduce those risks. This could mean that essential information is missed, and plans are not effective in safeguarding children.

Not all new members of staff have completed mandatory training before starting to work with the children. This includes training in first aid and safeguarding. On two separate occasions, untrained staff have supported children in the community without suitably qualified staff present, which has left children at potential risk of harm.

Children rarely go missing from this home. Staff understand the missing-from-care procedures. They speak knowledgeably about how they would respond should a child go missing from care. Despite regular discussions with children, staff do not



routinely discuss the risks of going missing. This does not help children to understand the risks of going missing. This means that children to do not learn how keep themselves safer in the community.

Physical intervention is rarely used and only used as last resort to manage unwanted behaviours and to keep people safe. Following incidents, reflective discussions are held with children in a timely manner. Staff discussions also take place swiftly. In addition, the manager has good oversight to ensure that the use of physical intervention is proportionate and appropriate. This practice helps to keep children safer.

Staff recruitment is effective and helps to prevent the employment of unsuitable staff. Leaders and managers carry out all necessary employment checks and verify these checks before staff work in the home.

The effectiveness of leaders and managers: requires improvement to be good

The registered manager is supported by a deputy manager who, along with the staff, is committed to helping children.

The systems to monitor the quality of care provided are not effective. The registered manager does not have sufficient oversight of the service and does not monitor the home effectively. She does not use the available internal auditing tools to monitor or review staff practice, shortfalls in children's care, records and documents. The registered manager has failed to identify areas of poor practice. This means that there is insufficient scrutiny of the care that children receive, which limits the opportunity to drive improvement forward.

An independent visitor regularly visits the home. The reports compiled following these visits provide sufficient information on the quality of care provided at the home. However, the independent visitor rarely seeks feedback from children's families and professionals. This limits the opportunity for leaders and managers to consider the views of others in their development plans for the home. It also makes it difficult for the independent visitor to form an accurate assessment of whether staff are safeguarding children and promoting their well-being effectively.

Staff attend regular team meetings and supervision sessions to help them to reflect on and develop their practice. The staff say that they feel supported and happy in their roles. The 'employee of the month' award boosts staff morale. This creates a positive and relaxed atmosphere for children, which helps them to develop.

Staff at the home have positive relationships with social workers, teachers and other agencies. This provides children with joined-up care and support.



What does the children's home need to do to improve? Statutory requirements
