Information about this children's home

This home is operated by a local authority and is approved by the Secretary of State to restrict children's liberty.

The home provides care for up to five children aged between 10 and 17 years who are placed by local authorities under section 25 of the Children Act 1989. At the time of this visit, five children were living at the home.

The admission of any child who is under 13 years old requires the approval of the Secretary of State, under section 25 of the Children Act 1989.

The commissioning of health services at this home is the statutory responsibility of NHS England under the Health and Social Care Act 2012. Education is provided on site in dedicated facilities.

The registered manager has been in post since May 2013.

This monitoring visit

This monitoring visit was carried out in line with the memorandum of understanding between Ofsted and the Department for Education (DfE).

Inspectors visited the home with specialist architects commissioned by the DfE. This visit forms part of the information that Ofsted provide to the DfE so that the Secretary of State can make a decision about the continuing suitability of the home to restrict children's liberty.

The home has a good standard of decor and furnishings throughout and is suitable for the children it provides for.

The requirements and recommendations made at the last inspection have not been checked to decide if they are met. These are not included in this report and will be reviewed at the next inspection.
