Summary of key findings

This provision meets requirements

- The childminder explains the importance of sharing information with parents and other settings that children may attend. She describes how she will help children to feel safe and secure, by obtaining information from parents regarding their individual needs. The childminder also explains that she shares information with parents about children's progress and ways to help children continue their learning at home.
- The childminder explains how she keeps her knowledge up to date and refreshes her skills. For example, she completes her own online research and training.
- The childminder provides a clean, secure and suitable premises for providing childcare. She has a range of suitable resources which she can use to help children to develop in the seven areas of learning.
- The childminder explains clear strategies for supporting children's communication and language development, including for children who speak English as an additional language. She describes how she will use songs, rhymes and books to encourage children to talk and will gather key words from parents to support children's understanding.
- The childminder demonstrates a clear understanding of how children learn. She is aware it is important to get to know each child's unique interests and capabilities and use these to plan activities to promote their development. The childminder will track children's progress and intends to use her assessments to plan for their next steps in learning.
- The childminder recognises the importance of promoting children's good health. She knows to provide children with a healthy diet and regular opportunities for physical exercise outside in the fresh air.
- The childminder keeps her paediatric first-aid training up to date. She is clear on her role and responsibilities in keeping children safe from harm. The childminder has a secure knowledge of local safeguarding concerns, which may affect children. She is confident in monitoring, recording and reporting concerns. The childminder keeps her home safe and will risk assess outings, ensuring children are safe by continually checking for hazards.
- The childminder knows how to support children to develop their understanding of good behaviour. She speaks of the importance of explaining to children how actions may affect others and how she explains acceptable behaviour. This includes helping children to learn that all children are individuals and are welcome into her home.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- This was the first routine inspection the childminder received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the childminder and has taken that into account in their evaluation of the childminder.
- The childminder showed the inspector the premises and discussed how she ensures they are safe and suitable.
- The inspector discussed with the childminder how she intends to deliver the curriculum for children and undertake observation, assessment and planning.
- The inspector checked the childminder's understanding of the safeguarding and welfare requirements.
- The inspector considered how the childminder plans to work in partnership with parents and other professionals.



We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
