Inspection judgements

Overall experiences and progress of children and young people: good

The child has positive relationships with the staff. The staff make sure that the child has lots of opportunities to share their wishes and feelings. They listen to the child and support them to achieve their goals. Consequently, the child feels a sense of value and respect, and this helps them to grow in confidence and explore their own identity.

Although the child has been out of education for a long period of time, the staff are ambitious for the child to achieve. They are working alongside a personal tutor to support the child to establish an enjoyable learning routine. The child is now engaging in a bespoke education programme in the home. This is the first step of a personalised plan to support the child to return to more-formal education. Working at this pace gives the child the confidence to learn and reduces their anxieties. The tutor commented, '[Child's name] is doing very well. Their progress now is incredible.'

The child attends routine health appointments, and staff help them to understand the importance of healthy eating and staying physically well. With advice and support from the organisation's in-house psychologist, the staff are able to recognise when the child needs additional mental health or emotional support. Staff adapt their approach and practice to meet the child's changing needs.

The child is learning the skills that help them to move towards independence. The skills they learn help them to prepare for later life. The tasks they complete include doing their washing, keeping their room clean, and cooking.

The child is enjoying new activities, which enhance their life experiences. These opportunities are helping them to develop their social skills and confidence, as well as new hobbies and interests.

The staff help the child to feel a sense of belonging. The staff team has recently created a surprise redecorated bedroom around the child's choice of colours and wallpaper. The child enjoys the home, which is generally well kept and homely. The kitchen area has some damage to worktops, door handles and some cupboard doors. This damage in the kitchen does not create a well-cared-for feel in this area.

How well children and young people are helped and protected: good

The child's risk assessment is regularly updated, and staff use this detailed document to help them to support the child during times of crisis. This approach means that the risks to the child continue to reduce. One professional commented, 'The risks were significant before the child moved in to the home. The staff have provided good-quality care and risks are significantly reduced now.'

The staff use their positive relationships with the child to de-escalate any challenging incidents. They listen to the child and take time to understand how they are feeling. They use agreed strategies, such as giving the child space and time on their own when they are angry or frustrated. As a result, there has been no use of physical restraint since the last inspection.

The staff complete training to help them to understand risks to the child. This training includes online safety, child exploitation and radicalisation. The staff all know how to report safeguarding concerns and ensure that any allegations are quickly responded to.

The staff undertake some work with the child to help them to understand possible risks to their safety, and the child is now reporting some issues to staff if they feel concerned. However, this work is not always well recorded. This means that the manager is unable to fully review how effective this work is in helping to manage and reduce risks.

The child does not regularly go missing from the home. On the one occasion that the child was missing for a short period of time, the staff followed the missing-from-home procedures, searched for the child and worked closely with the police. Consequently, the child was quickly located and safely returned to the home.

The effectiveness of leaders and managers: good

The manager is keen to continue to develop this service. He is working to continue to develop the team, and is ambitious for the child to achieve. The manager has support from the responsible individual, who has good oversight of the home and care practice. This shared ethos between managers and staff supports the child to make good progress.

The manager's monitoring systems are not fully effective. Some areas of recording have gaps, such as in one-to-one work with the child. Gaps in recording are not helping the manager to track the child's progress. Oversight from the responsible individual is helping the manager to identify the strengths of the service and the areas for development.

The staff feel well supported by the manager. They feel that they can ask him and the deputy any questions at any time. Staff receive regular formal supervision, where they can talk about their work. In these supervision sessions, they focus on the child and their progress, and look at what is going well and where they can improve.

The registered manager is a strong advocate for the child. He works alongside other professionals and challenges them, when needed, to make sure that the child can access the services and help that they need. One social care professional said, 'The manager continues to chase up progress on the child's plans. He is a strong advocate, and the staff go over and above.'
