## Information about this children's home

This children's home is operated by a large independent national provider. This home is registered to care for up to five children. The home operates as a short-breaks provider. There are currently 16 children who visit for short breaks and three children receiving extended breaks. During the inspection, three children were visiting.

The manager registered with Ofsted in March 2016.

## **Inspection judgements**

#### Overall experiences and progress of children and young people: good

A stable, confident staff team supports children to enjoy their short breaks. Children are at the heart of care in this home. Staff know children well, and therefore how to support them. Children enjoy a range of varied activities. At the home, there is a large garden, well equipped for imaginative play, active play or even water play. Children have the opportunity to go on trips to the park, the beach and swimming pool. In school holidays, they go on trips further afield, to safari parks and theme parks.

Careful planning takes place when children join the service. This ensures staff know the information they need to plan safe and enjoyable breaks. Managers understand which children will enjoy spending time together, and help staff know how to support them.

Children have clear targets to work towards. These often link to education targets, to avoid there being too many different demands on children. Photos help staff show parents and professionals the progress children make. Staff monitor children's progress monthly and modify targets as children achieve them. However, some records do not make it clear why targets are not changed when it states they are met.

Staff seek feedback from children and use this to understand how they enjoy their visits. Parents say their children enjoy their short breaks. They say the care is 'amazing' and well planned for their children. Parents enjoy finding out about the new things children have done, and about the time they spend with friends.

The home is welcoming and child-centred. Rooms are personalised for children's stays. Children have the same room each time they stay and this familiarity of routine helps them to settle. Repair work has been completed to the floor of one bathroom, however, the bath in the other still needs replacing.

#### How well children and young people are helped and protected: good

Children's behaviour is well managed. Clear plans show staff how to care for children during their stay. These documents help staff to create the right environment to give children positive experiences. When incidents do occur, staff receive debriefs which help managers identify learning. While there are clear records of incidents, the language used in the documents is not always child-friendly.

Managers support staff with regular conversations about safeguarding. This includes discussions about the purpose of body maps and what to do when there are concerns. This helps to maintain staff confidence in safeguarding children.



The home environment is safe and well maintained for children. All children have individual plans to help staff support them in the right way in the event of a fire. Children have opportunities to practise leaving the building safely, through regular fire drills. The manager consults with other agencies locally to consider the safety of the location.

#### The effectiveness of leaders and managers: good

An experienced manager leads the home. Since the last inspection, leaders and managers applied to Ofsted to vary the conditions of the home's registration. This was approved, and the home can now offer extended breaks to children who require more care. This supports children with more complex needs to live with their family for longer than might otherwise be possible. The needs of children remain central to the ethos of the home.

Staff enjoy working in the home. They feel supported by the manager and each other. Staff understand the need to be flexible when planning for children's care and support each other as a team to make children's stays enjoyable. Staff receive regular supervision and training. Staff value the training, saying it offers them new ways of thinking.

Staff have access to clear plans and information about children. This helps them to deliver consistent care that meets children's needs. Managers attend children's review meetings with other agencies and contribute towards the wider planning for children. Social workers speak highly of the support offered. They say it offers a home-from-home environment for children.

Since the last inspection, a new independent person has been carrying out visits to the home. Their reports provide the manager with challenge and scrutiny to drive improvement.



### What does the children's home need to do to improve? Recommendations

- The registered person should ensure that it is clear what progress children make against their targets so it can be seen when there is a need for new targets to be set. ('Guide to the Children's Homes Regulations, including the quality standards', page 14, paragraph 3.2)
- The registered person should ensure that the remedial work needed in the upstairs bathroom is completed to provide children with a welcoming and homely environment. ('Guide to the Children's Homes Regulations, including the quality standards', page 15, paragraph 3.9)
- The registered person should ensure that language used in documents is childfriendly. ('Guide to the Children's Homes Regulations, including the quality standards', page 62, paragraph 14.4)

Inspectors have looked closely at the experiences and progress of children and young people, using the social care common inspection framework. This inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with The Children's Homes (England) Regulations 2015 and the 'Guide to the Children's Homes Regulations, including the quality standards'.
