Summary of key findings

This provision meets requirements

- The childminder has in-depth knowledge on child development. She knows how to plan and deliver a curriculum that is age-appropriate and stimulating, based on children's interests. She explained how she would implement a broad range of learning experiences, both indoors and outdoors. The childminder plans to make use of the local woodlands and parks to enhance children's learning. She also plans to provide excursions to broaden children's experiences.
- The childminder understands how to promote children's independence. She plans to provide opportunities for children to develop their self-care skills and to encourage them to take care of their environment, including looking after, and tidying away, their toys.
- The childminder has good knowledge of how to set boundaries. She discusses the importance of consistent routine to support children to understand what is required of them.
- The childminder ensures that she maintains her own continuous professional development. She undertakes regular training courses to build on her existing knowledge. For example, she is taking a course on how to teach diversity to young children. The childminder works alongside other professionals. She uses her network to support reflection on her own practice. She also uses her peers to exchange ideas, knowledge and experience.
- The childminder understands how to build parent partnerships. She is able to explain the importance of communication in supporting relationships. She has a range of procedures in place to support these partnerships. The childminder enjoys supporting parents and lending her knowledge to them. She details how important it is that she works with parents to support their child's well-being and learning.
- The childminder knows how to keep children safe. She has a wide range of safeguarding knowledge. This includes topics such as substance misuse, online safety and radicalisation. The childminder understands the process for raising concerns that a child may be at risk. She knows how to contact the appropriate team within the local authority for support. The childminder puts a range of safety precautions in place in her home. For example, doors are locked and there are stair gates for areas that children do not use.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
