

# Inspection of Hubbub Out of School Club

# What is it like to attend this early years setting?

#### This provision does not meet requirements

Children's safety is compromised. Staff who transport children from school to the club do not have up-to-date first-aid training as required. Security arrangements at the club are not robust. There is a risk of children leaving the setting unnoticed, or unknown adults entering the premises. In addition, risk assessments are not effective and hazardous items, such as medicine, are sometimes left within children's reach. This does not ensure children's safety.

On arrival to the club, children enjoy a snack before playing with their friends. They form small groups and make up games with each other, taking turns to be imaginative characters. Children have the choice of resources. However, there are limited planned activities for children to engage in. Not all children are happy at the club. Some children say they 'want to be at home'. They have access to the school playing field and playground while the garden area is under construction works. Children enjoy running around the large field and they climb the trees. However, staff do not focus children's attention on meaningful activities. Children become disengaged and at times misbehave.

# What does the early years setting do well and what does it need to do better?

- The safeguarding procedures are not understood by all staff. Not all staff have had safeguarding training or know who the designated safeguarding lead (DSL) is. Staff are not clear about where the safeguarding policy is kept, so they can refer to it when needed. In addition, staff are able to use their own personal mobile phones while working with children. This does not ensure children's safety.
- At the time of the inspection, documentation was not accessible. Staff recruitment files and suitability checks were not able to be viewed or verified. The manager and deputy were unable to demonstrate that staff have undergone robust recruitment checks to be left in sole charge of children. This is a breach to requirements and does not demonstrate how children are being safeguarded.
- Children are not effectively safeguarded when being transported from school to the club. Staff who use their own vehicles to transport children on their own, do not all hold valid first-aid certificates. This means staff who accompany children on outings are not adequately trained to respond to an accident or injury. In addition, the manager and deputy were unable to demonstrate that staff have the correct car insurance to be able to transport children safely.
- Children attend the out-of-school club from the age of three years. At the time of the inspection, there were no qualified staff present. This does not meet the requirement to have a level 3 qualified member of staff working with any children who are younger than those in the reception class age range.



- Staff do not ensure the front door is locked after use. This means that children could leave the premises without an adult. Although the school premises are secure there are unknown adults arriving and leaving to collect children from the adjoining provision. This means that there is a risk of unknown adults entering the building. This does not ensure the children's safety.
- Risk assessments are not robust. The deputy manager and staff do not carry out effective risk assessments. For example, staff do not identify when medication has been left in reach of children. This does not ensure children's safety.
- Staff do not always respond to children's behaviour in a timely way and their approach to managing behaviour can differ across the provision. Despite this, children understand the rules and the routines. For example, they know they must line up and wait for every one before going inside after outdoor play.
- The key-person system is not fully understood by all staff. Some staff are not aware of who the key person is for early years children that attend. However, staff know the children well and what they like to do.
- Staff know about the needs of the children with special educational needs and/or disabilities (SEND). The special educational needs coordinator is not always based at the club but speaks to the schools about the progress children with SEND are making. Staff feedback that they are updated on the needs of children with SEND at group meetings.
- Parents are happy with the club. They feel informed about what their children have to eat. Parents use the club's website for any additional information and feel they can raise any concerns they may have.

# **Safeguarding**

The arrangements for safeguarding are not effective.

Staff do not know who the DSL is. They are not clear on the procedure to follow if there is an allegation made against a member of staff. Staff do not know where to find this information and have not all attended safeguarding training. The mobile phone policy is not clearly understood. Staff are able to use their own personal mobile phones to check children's attendance. Staff do not promote children's safety well enough when conducting risk assessments or transporting children to the club. Therefore children's safety is not assured.

# What does the setting need to do to improve?

The provision is not meeting requirements and Ofsted intends to take enforcement action.
