Summary of key findings

This provision meets requirements

- Since the last inspection, staff have now obtained relevant childcare qualifications. This supports their knowledge and understanding of the development of early years children.
- Staff demonstrate their understanding of planning a wide variety of engaging activities for children to participate in. For example, children have opportunities to do arts and crafts, construction, board games and puzzles at the club. They can use playground equipment and play sports, such as football, in the school playground. This ensures that children enjoy their time at after school club.
- Staff understand how to promote positive behaviour. They regularly remind children of expectations of behaviour and praise children when they follow these expectations. Staff interact calmly and positively with children to build warm relationships.
- Staff understand how to support children to lead a healthy lifestyle. Children help to prepare a healthy snack and have plenty of time to exercise in the playground.
- The manager holds staff meetings every half term. In these meetings, staff discuss the needs of the children and their planned activities for the term. The manager also shares safeguarding updates and other updates to policies and procedures with the staff. This supports staff with their professional development and leads to good outcomes for the children.
- The manager and staff understand the safeguarding processes that they need to follow if they have concerns about the wellbeing of a child. They attend regular safeguarding training. They know what to do if they feel that the conduct of a member of staff may be putting children at risk of harm. The manager follows robust recruitment processes. Children are kept safe while at the club.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The club is open only to children who attend the school. The provider employs three members of staff, including the manager. The staff all hold relevant childcare qualifications. The club opens during term time from 3.15pm to 6pm, Monday to Thursday.
