# **Summary of key findings**

#### This provision meets requirements

- The childminder has a secure understanding of her responsibility to keep children safe from harm. She recognises potential signs and symptoms that indicate a child may be at risk of abuse, including exposure to extremist views and behaviours. The childminder knows the procedures to follow for reporting any concerns about a child's welfare to the relevant agencies.
- The childminder understands the importance of providing a varied and sequenced curriculum. She describes how to plan activities based on children's interests, abilities and needs. The childminder is fully aware of promoting children's communication and language skills through activities, such as daily singing and sharing books with children.
- The childminder provides a safe and inviting environment with age-appropriate resources. She explains the importance of building warm relationships with children to help them settle, feel reassured and confident in her care. The childminder understands the importance of working closely with parents to support continuity of their children's learning and development.
- The childminder recognises the significance of gathering detailed information from parents at the start. She states that this enables her to support children's individual learning and development. She understands the need to assess children's knowledge, skills and understanding on a regular basis to highlight areas where children may need additional support. The childminder is aware that one of the roles of the local authority is to advise on areas she may need further help with.
- The childminder describes how to promote children's positive behaviour. She plans to introduce children to rules and boundaries to ensure a safe learning environment. She knows ways to help children recognise their emotions and aid their ability to self-regulate. The childminder understands how to help children to develop respect for others who are different to themselves.
- The childminder knows the importance of promoting children's physical development, a healthy lifestyle and independent self-care. She plans to organise daily opportunities for children to exercise in the fresh air in her garden and at local parks.
- The childminder knows how to keep her home safe and secure for children. She demonstrates how she intends to carry out regular risk assessments, indoors and outdoors. The childminder plans to teach children how to recognise and manage risks based on their age and level of understanding. This includes being able to cross the road safely with her when on outings.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
