What is it like to attend this early years setting?

The provision is inadequate

The procedures in place to keep children safe are ineffective. The provider has not developed robust processes to ensure children's safety, particularly when unvetted adults visit the premises to carry out temporary jobs. Staff do not always promote children's health and hygiene. They do not implement robust hygiene practices to help prevent the spread of infection. The managers and staff do not plan and implement an ambitious curriculum that meets the needs of individual children. Children who may have special educational needs and/or disabilities (SEND) roam around aimlessly and staff do not engage them in purposeful learning experiences. Children do not receive effective support to make good progress in the prime areas. Staff do not manage children's behaviour effectively. They do not help children to learn the value of turn-taking when playing with their friends. At times, when children push their friends, staff do not support them well enough to help them learn to self-regulate. Staff do not help children to understand the effect that their behaviour has on others. Staff do not effectively help children to learn how to use resources correctly, for instance as children explore equipment such as a bouncy chair.

What does the early years setting do well and what does it need to do better?

- The managers and staff allow external contractors who have not had effective vetting procedures into the setting and allow them to carry out work without supervising them. External contractors have access to environments while children are present. This demonstrates that children's safety is not assured.
- Overall, staff care for children. They know how to reassure them when they are upset and children willingly go to staff for comfort. However, staff deployment is poor in the outdoor area. At times, staff are left alone to care for the youngest children and those with SEND. Children do not always receive appropriate supervision to remain safe. This demonstrates that staff do not consistently support the individual needs of the children.
- The provider has not put in place an effective policy and procedure for administering medicines to children. Staff members do not know how to implement the provider's medicine policy. This compromises children's health and well-being.
- Staff do not provide children with strategies to manage their behaviour for themselves. They do not help children to understand how unkind behaviours make their friends feel. Staff do not help children to self-regulate their behaviours and to support their emotional health.
- The managers and staff show low ambition for what children with SEND can achieve. The managers rely on parents and other external professionals to lead in supporting children with SEND. Additionally, the managers do not put in place transition arrangements for children's next steps in education. This does not



prepare children, particularly those with SEND, for the next stage in their learning.

- The managers and staff do not keep accurate records to ensure the safe and effective management of the nursery. Staff do not maintain a daily record of the hours of children's attendance; in the event of an emergency, staff may not be able to safely account for all children.
- The provider is in breach of requirements relating to safety. Staff do not consistently clean their hands when they support children with cleaning their noses; staff then proceed to touch other children's faces. Children are not learning the links between good hygiene practices and good health.
- The provider does not implement and maintain a written record of complaints which includes the information received and the outcome of the complaint.
- Staff do not provide a curriculum that supports children's curiosity, awe and wonder. They do not engage, plan and implement effective learning experiences to support children's long-term education.
- The managers and staff are aware of children's allergies and individual dietary needs. They provide children with healthy snacks and meals.
- Parents comment that their children enjoy their time at the setting. Parents like the healthy snacks and meals that their children receive. Staff build positive relationships with children.

Safeguarding

The arrangements for safeguarding are not effective.

The provider does not ensure that appropriate suitability and oversight arrangements are in place for all adults who work on the premises. Staff do not ensure children are appropriately supervised at all times. This compromises the safety of children. However, staff know the procedures to follow to report any child protection concerns in line with their local safeguarding partnership. They know what to do in the event of an allegation against an adult being made.

What does the setting need to do to improve?

The provision is inadequate and Ofsted intends to take enforcement action.

We will issue a Welfare Requirements Notice requiring the provider to:

Inspection activities

- The manager and the inspector completed a learning walk together of all the areas of the setting and discussed the early years curriculum.
- The inspector viewed the provision with the manager and discussed the safety and suitability of the premises.
- The manager and the inspector completed a joint observation together.
- The inspector spoke to parents during the inspection.
- The inspector looked at relevant documentation and reviewed evidence of the suitability of staff working in the nursery.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
