Summary of key findings

This provision meets requirements

- The childminder demonstrates a good knowledge of safeguarding procedures. She explains clearly how she will recognise that a child may be at risk of harm. The childminder is aware of the correct procedures to follow to report concerns she may have about children in her care. She shows a good understanding of safer recruitment procedures to ensure children's safety and well-being.
- The childminder understands the importance of working in partnership with parents and other professionals. She explains how this consistent approach supports children's all-round development. The childminder discusses the importance of information sharing and good communication to ensure that the children in her care make good progress.
- The childminder explains how she will plan ambitious activities for children, based on their interests and learning needs. She talks about the importance of observing and monitoring children's learning and development to identify any emerging gaps in their development.
- The childminder demonstrates her understanding of how to support children with special educational needs and/or disabilities. She explains how she will work in partnership with parents and other professionals to support children.
- The childminder discusses how she will teach children the boundaries in her setting. She explains how she will talk to children to support them to understand their behaviour and feelings and the feelings of others. The childminder describes that this will help children to understand the impact their behaviour has on others.
- The childminder explains how she will promote healthy lifestyles. She explains how she will teach children about hygiene routines and healthy eating. The childminder talks about how she will provide water and healthy snacks, and teach children to make healthy choices. She discusses how she will use the garden and local parks to encourage children's physical development.
- The childminder explains how she keeps her continuous professional development current. She keeps her mandatory training up to date, such as safeguarding and paediatric first aid. The childminder actively seeks training to support her curriculum and how she teaches children.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
