Summary of key findings

This provision meets requirements

- The childminder discusses how she intends to plan a wide variety of interesting activities that will support children's learning and development across all areas of the curriculum. She also describes how she intends to monitor children's progress and plan new experiences to help them to develop new knowledge and skills.
- The childminder explains how she hopes to build warm and positive relationships with children. She highlights how she will teach children about boundaries, sharing and kindness to support their personal and social development.
- The childminder understands her responsibilities in relation to keeping children safe. For instance, she explains how she will recognise potential signs that may indicate that a child's welfare is being compromised. The childminder also understands signs that a child is being exposed to extreme ideas and views. Furthermore, she knows the importance of keeping written records and reporting any concerns to safeguarding professionals in the local authority.
- The childminder discusses how she is committed to offering an inclusive service. This is apparent in the way that she describes how she would make adaptations for children with special educational needs and/or disabilities and work with a range of other professionals to support children's learning.
- The childminder explains how she intends to teach children about diversity. For example, she discusses how she will learn about children's home cultures when they join and celebrate different festivals that are important to them. The childminder adds how she intends to broaden children's knowledge through art projects, sharing music and food.
- The childminder keeps all mandatory training up to date, including first aid and safeguarding. This positively contributes to her commitment to try to keep children safe.
- The childminder discusses how she intends to build trusting and open relationships with parents. She describes how she will seek lots of information from parents when their children first join. The childminder explains how she will keep parents updated about their children's current interests, new achievements and overall progress.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
