Summary of key findings

This provision meets requirements

- The manager is clear about her role and responsibilities to help keep children safe. She knows how to identify concerns about children's welfare and how to escalate these to relevant agencies. This includes how to recognise indicators that a child is being exposed to extremist views or behaviour.
- The manager works with parents to support children's care and development needs. She gives examples of how information is shared with parents, such as through verbal feedback and newsletters, to help keep them informed.
- The manager understands the need to work with teachers at the host school to complement children's learning experiences. She is committed to inclusive practice and liaises with teachers to offer children the support that they need.
- Children's well-being and emotional security are important to the manager. The young children will be appointed a key person who will get to know them and their families. The manager expresses her high expectations for children's behaviour.
- The manager discusses how she and staff intend to observe young children to inform their planning of activities. She gives examples of the toys and resources that are available to children to help keep them motivated to play.
- The manager knows how to promote children's good health and well-being. For example, she and staff will teach young children to wash their hands before handling food. They will offer children regular opportunities to play outdoors and have fresh air to support their growth and development.
- There are clear procedures in place to ensure that staff are suitable to work with children. Staff are offered supervision and training to develop their professional knowledge and skills.
- The manager is aware of the self-evaluation process. She intends to seek the views of parents and children to help identify the setting's strengths and areas for development.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The club employs four staff members, two of whom hold relevant childcare qualifications.

Inspection activities

- This was the first routine inspection the setting received since the COVID-19 pandemic began. The inspector discussed the impact of the pandemic with the manager and has taken that into account in their evaluation of the setting.
- The manager showed the inspector around the setting, inside and outside, and showed the toys and resources that will be made available for early years children. She told the inspector her expectations for children's behaviour while attending the setting.
- The inspector talked to the manager and a senior leader to discuss matters, such as the safety and suitability of the premises.
- The inspector looked at relevant documentation and reviewed evidence of the suitability of staff working in the setting.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
