Summary of key findings

This provision meets requirements

- Leaders and managers demonstrate a robust understanding of how children learn best. They discuss how they create an exciting environment that supports the interests and needs of all children who attend. Leaders explain how they promote children's independence by encouraging them to complete ageappropriate tasks throughout the day.
- Leaders have high expectations for children's behaviour. They explain how staff use age-appropriate methods to encourage positive behaviour, including through daily award ceremonies. The club adopts the behaviour management strategies of the host school. Leaders understand how this provides a consistent approach to supporting children's understanding of appropriate behaviour.
- Leaders and managers recognise the importance of working closely with families. They explain how staff share information verbally and by using an electronic journal system. Parents are invited into the club to watch performances and observe the activities their children have enjoyed. Leaders understand how this supports children to develop a sense of pride in their efforts and achievements.
- Leaders and managers demonstrate deep knowledge and understanding of how to safeguard children. They confidently discuss the signs and symptoms that could indicate that a child is at risk from harm and explain the correct process to follow when reporting any concerns. All staff regularly complete appropriate paediatric first-aid and safeguarding training.
- Leaders explain how staff support children's understanding of healthy lifestyles. They discuss how staff encourage children to enjoy healthy meals and snacks by being positive role models. Leaders explain how children have plenty of opportunity for physical activity. They engage in numerous sports activities that staff carefully plan and have continuous access to outdoor play.
- Leaders explain how they support children's understanding of diversity and respect for others. They discuss how staff encourage children to explore and celebrate different cultures and customs in age-appropriate ways.
- Leaders and managers explain how they support staff development and wellbeing. They discuss how they monitor staff performance and the methods of coaching they adopt. Managers talk about the award ceremonies and teambuilding activities they plan for staff. They explain how these events support staff practice and morale.
- Managers have robust methods to ensure that all staff are suitable to work with children. They explain the recruitment and induction processes that are in place for all staff and understand how these support children's welfare and development.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
