Summary of key findings

This provision does not meet requirements

- The childminder has not made the required improvements in her knowledge to meet the statutory requirements of the early years foundation stage. Many of the breaches of requirements found at this inspection have been raised before by inspectors. This means that there continue to be significant weakness in the quality of the provision.
- The childminder has a limited understanding and knowledge of the actions that must be taken if there are allegations made against her or a member of her household. Consequently, children's welfare cannot be assured.
- The childminder is able to identify some signs and symptoms indicating that a child may be at risk of harm. However, she does not know the correct procedure to follow to report these, in line with her local safeguarding partnership procedures.
- The childminder has limited understanding of the importance of creating an ambitious curriculum that is planned to build on children's knowledge and skills to help them gain new skills and abilities. She demonstrates poor understanding of how to design and implement a curriculum for groups of children of mixed ages.
- The childminder does not have sufficient knowledge of the learning and development requirements or the purpose of assessments, particularly the progress check at age two.
- The childminder has a limited awareness of effective strategies to support children to regulate their behaviour and emotions. The strategies she describes would not help children to understand what is right and wrong and would negatively impact their emotional well-being.
- The childminder does not effectively evaluate her practice. She has not engaged in professional development opportunities to ensure that her practice continually improves.
- The childminder cannot explain the necessary changes she needs to notify Ofsted about. Consequently, she failed to notify Ofsted of a significant event, which is a requirement of her registration.
- The childminder understands the importance of developing partnership with parents to ensure continuity of care for all children.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?



The provision is not meeting requirements and Ofsted intends to take enforcement action.

We intend to take steps to cancel registration and will issue a Welfare Requirements Notice requiring the provider to:
