Summary of key findings

This provision meets requirements

- The manager describes how children play an active role in planning activities and play experiences alongside staff, both inside and outdoors. Staff use information gathered from the school about learning opportunities children enjoy to build on what they already know.
- The manager demonstrates how staff work in partnership with parents and teaching staff to support children with special educational needs and/or disabilities to meet their needs.
- The manager and staff help children understand what behaviour is acceptable. They recognise and praise children's efforts and achievements. Staff encourage children to share and take turns. They understand the importance of acting as positive role models and praising children's good behaviour.
- The provider and manager work closely with staff. They demonstrate how they place importance on staff's well-being and professional development to continually build their knowledge and skills. Staff regularly come together to share ideas and cascade information gained from training courses they have completed.
- Staff demonstrate how they make sure children spend time outside being active and take steps to ensure that activities take place, both inside and outdoors. Staff encourage children's awareness of eating healthy snacks and the importance of drinking regularly. They encourage children to become confident individuals and follow appropriate hygiene routines.
- Staff describe how children are involved in making sure that the space they play in is safe. They involve children in assessing all areas to ensure that they are suitable and secure. Staff describe appropriate procedures to ensure that children arrive safely at the club after school.
- The manager explains how staff encourage children's awareness of different cultural events and celebrations throughout the year. Communication between staff and teaching staff ensures that any celebrations, themes or topics within school can be continued in club.
- The provider and staff demonstrate a secure knowledge of how to safeguard children. They describe signs that may indicate that a child is at risk of abuse and neglect and demonstrate what steps they would take to safeguard a child in their care.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
