## **Overall outcome**

The school does not meet all of the independent school standards that were checked during this inspection

## Main inspection findings

Part 1. Quality of education provided

Paragraphs 2(1), 2(1)(a), 2(1)(b), 2(1)(b)(i), 2(2), 2(2)(a), 2(2)(d), 2(2)(d)(ii), 2(2)(h), 2(2)(i), 3, 3(a), 3(c), 3(d), 3(e), 3(f) and 3(g)

- At the previous progress monitoring inspection in November 2022, there had been no improvement to the quality of education. Pupils continued to receive no creative or technological education. Leaders and teachers continued to lack subject and teaching expertise. Proprietors and leaders had not organised any training to improve quality. Pupils continued to have limited access to suitable fiction and non-fiction books.
- This inspection found there to have been some very recent improvements to the curriculum offer. From August 2023, pupils receive three rather than two secular lessons in the afternoons. Pupils now have open access to a small range of fiction and non-fiction books to read for pleasure. They had their first technological education lesson in computing in the week before this progress monitoring visit. Pupils still do not receive any creative education. An external consultant who has been supporting the school on a weekly basis from August 2023 is in the process of planning a programme of training to develop staff's subject and teaching expertise, but this has not commenced. Overall, these few, relatively positive changes are extremely recent. Leaders have done little since the previous inspection to develop the quality of education that pupils receive.
- The independent school standards (the standards) in these paragraphs remain not met.

## Paragraphs 2(2)(e)–2(2)(e)(iii)

- The previous progress monitoring inspection found that leaders had still not developed a careers programme for pupils since the time of the standard inspection in January 2022. Pupils continued to have no access to impartial information, advice and guidance.
- This inspection considered the school's proposed careers policy and plans. These lack detail, although they include references to the National Careers Service website and to a framework for best practice in careers guidance. Because the school's policy and plans have not been implemented, leaders still do not ensure that pupils have a broad view of



the careers options open to them, covering a broad range of the opportunities that are available to them and enabling pupils to make informed choices.

■ The standards in these paragraphs remain not met.

Paragraphs 2A(1), 2A(1)(b), 2A(1)(d), 2A(1)(e), 2A(1)(f), 2A(1)(g) and 2A(2)

- The previous inspection again reported that leaders had not developed and delivered a relationships and sex education (RSE) programme. Inspectors were presented with no evidence of a policy, parental consultation or curriculum plans.
- This inspection found that leaders have drafted a policy and written to parents and carers about their proposal to teach RSE, providing them with the option to withdraw their child from sex education. All parents have chosen to do so. However, leaders have not consulted parents in developing the policy. Leaders have only written an overview of some proposed RSE topics. Leaders have not planned the RSE curriculum, including for sex education in the case that a pupil is not withdrawn. Leaders have still not complied with statutory guidance and ensured that pupils are provided with relationships education in an age-appropriate way.
- The standards relating to RSE in these paragraphs remain not met.
- Most of the standards checked in Part 1 remain not met. All the standards checked are listed in full in the annex to this report.

## Part 2. Spiritual, moral, social and cultural development of pupils

## Paragraphs 5, 5(a), 5(b)(v) and 5(b)(vi)

- The standard inspection in January 2022 and the previous progress monitoring inspection in November 2022 found pupils' knowledge of other religions, faiths and cultures to be limited. Leaders did not actively promote respect for all groups of people, paying particular regard to the full range of protected characteristics. Leaders had taken no action to ensure that these aspects of the curriculum were thought through and implemented.
- This inspection found that pupils continue to have a limited knowledge of faiths, beliefs and cultures other than their own. Plans to deliver a discrete personal, social, health and economic education programme have not been implemented. Leaders have not given thought to the planning and delivery of the curriculum so that pupils develop knowledge and understanding of the protected characteristics in an age-appropriate way.
- The standards checked in Part 2 remain not met.

## Part 3. Welfare, health and safety of pupils

## Paragraphs 7–7(b)

- The previous inspection identified a range of serious safeguarding concerns.
- This inspection found that the safer recruitment processes followed when new staff join the school continue to be extremely weak. Statutory guidance for dealing with applications and interviews and seeking references for prospective employees is still not followed. As previous inspections have found, some staff, including those new to the



school, are working with pupils without having gone through a suitable recruitment process and pre-employment checks.

- Currently, the acting headteacher is fulfilling the role of leader with responsibility for safeguarding. He and a deputy are suitably trained. The school's safeguarding policy has been updated and reflects the latest statutory guidance. However, leaders have not shared the updated policy or the latest statutory guidance ('Keeping Children Safe in Education', September 2023) with staff. Established staff have not received training in the light of this guidance. Staff new to the school this academic year have not had an introduction to the school's safeguarding processes.
- This standard remains not met.

## Paragraph 12

- The previous inspection found checks on fire safety equipment, including extinguishers, to be overdue. Checks carried out by external professionals on the emergency lighting in November 2021 stated that many units were faulty. These did not appear to have been fixed. The next annual check was overdue.
- This inspection found some checks to have been brought up to date, including on fire extinguishers. However, checks on the emergency lighting in November 2022 state that there continue to be seven faulty units. Leaders have not arranged for these to be repaired. The latest external risk assessment suggests that there are also concerns about fire doors, although it does not make clear what these are. Leaders have not followed this up.
- This standard remains not met.

#### Paragraph 13

- The previous inspection found there to be only one member of staff with in-date first-aid training. This was insufficient because in their absence there was nobody else qualified to care for sick and injured pupils.
- This inspection found there to now be three suitably qualified first-aiders.
- This standard is now met.

#### Paragraph 15

- The previous inspection found the school's admissions and attendance registers to be not compliant. There were inaccuracies, including missing pupils. Admission dates for pupils were incorrect. The register did not include the addresses of pupils' previous schools. Sometimes, incorrect attendance codes are used in the attendance registers.
- This inspection found the admissions register to include all the required information for the nine pupils on roll. From August 2023, attendance registers now make accurate use of attendance codes.
- This standard is now met.

#### Paragraphs 14 and 16–16(b)

The previous inspection identified weak arrangements for risk assessment and supervision. Pupils were allowed to leave the school site to buy lunch in the local shops without adult supervision. Pupils were also able to access potentially dangerous areas of



the school, such as the roof. The written risk assessment for the premises lacked rigour and relevance.

- This inspection found that pupils are no longer allowed to leave the premises unaccompanied during the school day for any reason. Roof fencing has been repaired. The written risk assessment for the premises, though still lacking some detail in a few areas, has been revised and is now suitable overall.
- These standards are now met.
- Some of the standards checked in Part 3 continue to be not met, as listed in the annex.

## Part 4. Suitability of staff, supply staff, and proprietors

Paragraphs 18(2)–18(2)(e), 18(3), 21(1) and 21(3)–21(3)(b)

- The previous inspection found the single central record (SCR) of pre-employment checks on adults to be not compliant. Some staff, including the acting headteacher at the time, were not listed on the SCR. The way in which some pre-employment checks were recorded in the SCR was unclear, including those relating to working in the United Kingdom. Barred-list checks were missing. Leaders' knowledge and understanding of the requirements in this part were weak.
- This inspection found that improvements have been made to the SCR. For example, all the required adults are included. However, the record-keeping of some checks continues to be disorganised. Barred-list checks, although completed, continue to be omitted from the SCR. Additional checks on those previously living or working overseas are not being undertaken or recorded.
- Some standards checked in Part 4 are now met, but some remain not met, as listed in the annex.

## Part 5. Premises of and accommodation at schools

## Paragraphs 24(1)-24(1)(b)

- At the previous inspection, leaders were unclear about which room was allocated for the care of sick and injured pupils.
- This inspection confirmed that a suitable medical room is available to pupils.
- This standard is now met.
- The standards checked in Part 5 are now met.

## Part 6. Provision of information

## Paragraph 32(1)(c)

- The school's safeguarding policy is now readily available in hard copy on request as required because the school does not have a website.
- This standard is now met.



## Paragraphs 32(1)(j) and 32(4)(b)

- Leaders have now updated their admissions policy to inform prospective parents that the school is subject to a restriction order.
- These standards are now met.
- The standards checked in Part 6 are now met.

## Part 8. Quality of leadership in and management of schools

## Paragraphs 34(1)-34(1)(c)

- The previous inspection reported that the quality and capacity of leadership had deteriorated further since the standard inspection in January 2022. Inspectors identified serious and wide-ranging concerns. There was a desperate lack of leadership capacity. Weaknesses in the quality of education remained. Progress in improving the school was non-existent. Many more standards were judged to be not met in November 2022 than was the case in January 2022.
- This inspection found there to have been extremely recent changes to the school's leadership arrangements. From August 2023, the headteacher and a senior leader of Lubavitch Yeshiva Katanah of London are now leading this school, with the support of an external consultant.
- Leaders have resolved some of the urgent concerns, such as those relating to risk assessment and supervision of pupils. They have made sure that there is access to a suitable medical room, ensured that the admissions register is correctly maintained, and provided first-aid training to more staff than was previously the case.
- However, they have not ensured that the school has a suitably rigorous safeguarding culture. Proposals to improve the quality of education are brand-new at the start of the autumn term 2023. Ten months after the previous progress monitoring inspection, the school's leaders are not much closer to meeting all the standards. Leaders have not demonstrated that they have the required capacity to improve the school.
- The standards checked in Part 8 remains not met.

## Schedule 10 of the Equality Act 2010

- At the previous inspection, leaders were unable to present an accessibility plan for the school.
- This inspection found that the school has an out-of-date accessibility plan. It is overly generic and lacks detail regarding what the proprietors intend to do to increase accessibility to the premises, curriculum and written information.
- This requirement remains not met.



## **Compliance with regulatory requirements**

The school does not meet the requirements of the schedule to the Education (Independent School Standards) Regulations 2014 ('the independent school standards') and associated requirements that were checked during this inspection, as set out in the annex of this report. This included the standards and requirements that the school was judged to not comply with at the previous inspection. Not all of the standards and associated requirements were checked during this inspection.

## Information about this school

- Lubavitch Senior Boys School is an independent secondary day school with an Orthodox Jewish religious ethos. It is located in the London Borough of Barnet. The school occupies the first floor of premises that it shares with Lubavitch Yeshiva Ketanah of London school for boys aged 13 to 16. The two schools share some resources and staff, including senior leaders. The acting headteacher is also a senior leader at Lubavitch Yeshiva Ketanah of London.
- The school's latest inspection was a progress monitoring inspection in November 2022. The previous standard inspection took place in January 2022, when the school was judged again to be inadequate. The Secretary of State for Education imposed a restriction



on the school on 13 October 2021. The restriction, effective from 11 March 2022, means that the proprietors must not admit any new pupils to the school. At the previous inspection in November 2022, the proprietors were not complying with the restriction. This was because there was evidence that pupils had been admitted after 5 September 2022. This inspection found the proprietor to now be complying with the restriction. No further pupils have been admitted since the previous inspection on 15 November 2022. The number on roll has decreased from 19 in November 2022 to nine pupils, who are all in Year 8. There are no pupils in Year 7. The school is registered to admit 40 pupils.

- On 27 March 2023, the Department for Education wrote to the proprietors to confirm the Secretary of State for Education's intention to remove the school from the register of independent schools.
- Leaders have not updated 'Getting Information about Schools' (GIAS), which continues to record the name of the previous substantive headteacher, Yosef Weisz.
- The school makes no use of any alternative provision.



## Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- This was the second consecutive progress monitoring inspection since the school's previous graded inspection in January 2022. The preceding progress monitoring inspection was in November 2022. This inspection was conducted without notice.
- The focus of the inspection was to check whether the school complied with particular requirements in Parts 1, 2, 3, 4, 5, 6 and 8 of the independent school standards, as well as schedule 10 of the Equality Act 2010.
- Inspection activities included meetings with the acting headteacher, consultant headteacher and a governor. Inspectors also toured the premises.
- Inspectors met with all the pupils in attendance. In line with leaders' request, inspectors did not ask pupils anything about sex and relationships education.
- Inspectors reviewed a range of evidence to check compliance with the independent school standards.
- There were no recent responses to the online survey, Ofsted Parent View.
