# **Summary of key findings**

#### This provision meets requirements

- The childminder has a secure knowledge of safeguarding and understands her responsibility to safeguard children. She knows the potential signs and indicators that may suggest that children are at risk. The childminder updates her knowledge of safeguarding every year. She is clear about the referral procedures to follow if she has any concerns about children.
- The childminder describes how she would make sure that the areas of her home used for childminding are safe and secure for children. She plans to section off areas of her large garden so that children have a secure grassed and paved area to play in. She holds a paediatric first-aid qualification.
- The childminder has a strong knowledge of the learning and development requirements. She understands the areas of development and confidently talks about her curriculum. Furthermore, she describes how she will organise the environment and routine so that children can spend lots of time playing. She intends to follow children's interests and help them make progress through questioning and challenge. She discusses her intention to observe children's progress to help her identify any gaps in their development.
- The childminder explains how she will develop a supportive partnership with parents. She describes how she will talk with parents to find out about their children. She plans to talk to them every day about what their children have been doing. She will use development guidance to help her share information about children's progress and to support learning at home.
- The childminder prioritises professional development. She accesses a wide range of training opportunities to keep her early years knowledge up to date. She is proactive in accessing support and advice from, for example, the local authority.
- The childminder talks with passion about the range of activities that she plans to do with children. These include trips out to local parks and nature areas for fresh air and exercise. She is keen to use the local library to support children's love of reading. In addition, she is excited to support children's understanding of healthy eating by providing cooking and baking activities.
- The childminder discusses how she will encourage positive behaviour and provide clear boundaries for children. She explains how she will encourage children to have good manners and help them form friendships. She describes how she will help children to develop their understanding of the diverse local community and of the wider world.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
