What is it like to attend this early years setting?

This provision meets requirements

Children are happy when they arrive at the club and they are eager to tell staff news about their day. Children are collected from their classes and welcomed by the friendly and caring team. Staff plan the room around their knowledge of children's interests to capture their focus and imaginations. Children settle quickly and demonstrate confidence in selecting other resources to play with from the wide range accessible to them. Children know the routines and seem to be comfortable in their surroundings. They have secure relationships with the staff and their peers. Children develop nice friendships within the club. They play cooperatively together and use their imaginations to create their own games. Children enjoy working together to build with the bricks and to play imaginatively with the playhouses and vehicles. Older children support the younger children. For instance, they encourage them to take part in activities, such as arts and crafts.

Staff set clear and consistent routines and boundaries so that children know what is expected of them. Children help to tidy away after snack, set up activities and tidy away toys and equipment when they have finished with it. Children show kindness and respect to their peers as they share resources and involve others in their games. All children behave well.

What does the early years setting do well and what does it need to do better?

- Since the last inspection, the manager and staff have worked hard to raise the quality of the provision and make the necessary changes and improvements. They have taken part in training, reviewed their procedures and improved their record keeping and information sharing. All staff say that they are well supported to develop their skills and knowledge further.
- Staff have a good understanding of how to engage children and support their needs. Younger children have their own key person who helps them to settle. Staff get to know the children well, and they spend time talking with children and playing alongside them. Staff are interested in what children have to say, and they praise them for their achievements and encourage them to take part in the activities on offer. Children enjoy painting and being creative. For instance, they paint their own stained glass fish and make bracelets. Children excitedly share their artwork with parents when they arrive to collect them.
- The manager and staff have a good partnership with the host school. They recognise the importance of working with the teachers to help children and to share information when needed. Staff offer parents support when their children are struggling with an area of their learning, and they are keen to work with children's teacher to help them in the club. Some children spend time doing their homework and staff are happy to support children with reading and spellings.



- Staff recognise children's different needs; some children like to be active, and they have opportunities to be physical and play outside. Children enjoy using the different equipment, chasing bubbles in the playground and using the balance boards, where as other children like playing football with their friends. Staff provide areas where children can rest and look at books as they recognise that some children need time to relax after they have had a day at school.
- Staff help children to learn how to keep themselves healthy. Children follow good hygiene practices. They routinely wash their hands on arrival and before meals. Children are reminded to have frequent drinks and to rest when they are becoming too hot after running around. Staff provide a healthy and well-balanced snack for children and they consider the dietary needs of all children.
- Parents say that they are happy with the club and the friendly staff who care for their children. The manager and staff gather information from parents about their children to help them to plan for them. For example, they find out about children's likes and dislikes, and any medical or dietary needs. Parents comment that their children enjoy attending and often do not want to leave.

Safeguarding

The arrangements for safeguarding are effective.

The manager and staff have a good understanding of their responsibilities to safeguard children. They have refreshed their knowledge of child protection and safeguarding to ensure that they are all aware of the signs that could indicate a child is at risk of harm. All staff are confident with the procedures to follow if they have any concerns about children's welfare. Staff carry out risk assessments of the resources, hall and playground, and they make sure that they supervise children well and escort them into the school to use the toilets. This helps to keep children safe.

Elmbridge Childcare Club registered in 2021. It operates from Elmbridge Primary School in the Longlevens area of Gloucester. The club is open each weekday, from 7.15am to 9am, and from 3pm to 6pm. The holiday club opens from 7.30am to 6pm during school holiday periods. The club employs six members of staff, including the manager. The manager holds a level 5 qualification, the deputy manager and the playleader hold a level 3 qualification, and other staff hold a level 2 qualification.
