#### Information about this children's home

The home is owned and operated by a private company. It provides care for up to three children with special educational needs and/or disabilities.

There has been no registered manager since June 2022. A manager has been appointed and intends to make an application to register with Ofsted.

### This monitoring visit

On 23 May 2023, Ofsted imposed a condition of registration requiring the provider to give Ofsted three months' notice of its intention to move a child into the home.

On 17 July 2023, the provider confirmed to Ofsted that it intended to reopen the home. The purpose of this monitoring visit was to assess the provider's readiness for children to move into the home.

The home has been refurbished throughout to a good standard. This has included work to ensure that the premises is structurally sound. The addition of a playroom for children to use on the first floor and a family room in an external building means that there is plenty of space for children to spend time together or alone. Children's bedrooms are warm and welcoming spaces that can be personalised by children.

The home has sufficient staff to care for children safely. There is a mix of skills and experience within the team. New staff receive an induction to their work and there is an established training programme to ensure that all staff are suitably equipped with the knowledge and skills required to support children and meet their needs. Those staff who do not hold a diploma in residential childcare are enrolled on the appropriate course.

The manager has ensured that new staff have been safely recruited and that their suitability to work with children has been assessed.

As a result of this monitoring visit and subsequent information provided by the provider in relation to the premises, the condition of registration requiring the provider to notify Ofsted of its intention to move a child into the home has been removed.
