**Overall outcome** 

The school meets all of the independent school standards that were checked during this inspection

# Main inspection findings

### Part 1. Quality of education provided

Paragraphs 3(a) to 3(f)

- This independent school standard (the standard) was not met at the inspection in February 2023. The inspection report stated that the curriculum did not identify how knowledge will build over a term or an academic year. The inspection also found that the activities that the school chose for pupils to complete were not well matched to the intended learning. The teaching of phonics was also identified as an area for improvement as staff did not implement the approach to phonics well enough. Also, pupils struggled to read the books they received because these were not well matched to the sounds they had learned.
- In the evaluation of the action plan in June 2023, the school stated they would create progression maps to show how learning would build on prior knowledge. There would also be investment in a new phonics programme, with training for staff on this approach. The school also planned to invest in new reading books to match closely to the sounds pupils were learning.
- There is now a coherent curriculum in place that identifies how pupils will build on their knowledge over time. The school's progression maps show how learning will build each term and each year.
- The school has adopted schemes for teaching mathematics and phonics. Staff have been trained in how to teach these schemes.
- The school has also used externally published resources to support the design of other curriculum areas.
- The school has rigorously assessed pupils' phonics knowledge to ensure they provide reading books for pupils that match the sounds they have learned and should know.
- Work in mathematics books reflects the planned curriculum and shows the school is implementing plans more consistently than previously.
- There are plans in place to monitor the effectiveness of the teaching of the curriculum and provide further staff training where required.
- This standard is now met.



#### Part 3. Welfare, health and safety of pupils

### Paragraphs 7, 7(a), 7(b)

- The school ensures that the safety of pupils is of the highest priority. Staff understand how to identify the signs a pupil may be at risk of harm. They record concerns promptly using the procedures agreed at school.
- The school takes action on concerns quickly. Where required, additional support is provided to pupils and families.
- This standard was met at the previous inspection and remains met.

#### Paragraph 11

- The school has relevant and updated health and safety policies in place. These are implemented appropriately by staff.
- The school completes necessary health and safety checks at appropriate intervals.

#### Paragraph 12

- There is an appropriate fire risk assessment in place. The school ensures this risk assessment is regularly reviewed and updated. For example, where building work has happened, the school has reviewed evacuation procedures.
- The school ensures that checks on emergency lighting, fire alarms and fire extinguishers are completed.

#### Paragraphs 16, 16(a), 16(b)

■ There are relevant risk assessments in place. The school regularly reviews these risk assessments to ensure the implications of any changes to the school site are well considered. Risk assessments set out what the dangers are, what the impact might be and how the school will manage the risk.

#### Part 4. Suitability of staff, supply staff, and proprietors

#### Paragraphs 18 to 21

- The school has maintained the robust procedures they had in place at the previous inspection for the safer recruitment of staff.
- Leaders regularly quality assure the school's single central record of background checks on adults to ensure it is accurate.
- This standard was met at the previous inspection and remains met.

#### Part 5. Premises of and accommodation at schools

#### Paragraphs 23 to 31

- The premises are well maintained and conducive to use as a place of learning. This includes pupils' access to suitable toileting facilities, drinking-water and a medical room.
- There is outside space for pupils to play and to take part in physical education lessons.
- The school has sensible plans in place to enhance the premises at Ashley House. The development of a library space, for example, will further improve the learning environment for pupils. The school also plans to utilise space in the local community to enhance the physical education provision on offer.

■ The new building, as well as the existing school premises, meet the standards outlined in part 5 of the standards.

#### Part 6. Provision of information

Paragraph 32(1)(c)

- The school's safeguarding policy reflects relevant statutory guidance and is available on the school's website.
- This standard was met at the previous inspection and remains met.

### Part 8. Quality of leadership in and management of schools

Paragraphs 34(1) to 34(1)(c)

- This standard was not met at the inspection in February 2023. The inspection report stated that the school had limited capacity to improve provision.
- In the evaluation of the action plan in June 2023, the school stated they would restructure the leadership team and provide external support and coaching to add capacity to leadership.
- The school has built increased capacity in the leadership team through new appointments. There is also increased capacity across the Include Schools with central staff supporting the monitoring and quality assurance of provision.
- The school has ensured that the action plan has been well implemented. This includes prioritising improvement work appropriately. For example, using staff training to upskill staff in how to teach phonics, knowing the ability to read improves pupils' access to the wider curriculum.
- There are clear systems in place to monitor the quality of education pupils receive. A focus on coaching, mentoring and modelling of best practice has been established to develop staff across the three school sites.
- This standard is now met.

  - 3(e) Demonstrates good knowledge and understanding of the subject matter being taught;
  - 3(f) Utilises effectively classroom resources of a good quality, quantity and range;

### Part 8. Quality of leadership in and management of schools

- 34(1) The standard about the quality of leadership is met if the proprietor ensures that persons with leadership and management responsibilities at the school-
  - 34(1)(a) demonstrate good skills and knowledge appropriate to their role so that the independent school standards are met consistently;

#### Information about this school

- The school is split over three sites. These are the registered Ipswich site; the Old Kingdom Hall, Short Bracklands, Bury St Edmunds, Suffolk, IP33 1EL; and Ashley House, Ashley Downs, Lowestoft, NR32 4EX.
- The school moved to the Ashley House site in Lowestoft from another premises in Lowestoft in September 2023.
- The school has a contract with Suffolk local authority to provide 66 alternative provision places for pupils in key stages 1 and 2. Some pupils are on a dual roll with their home school. Others have been permanently excluded from their last school.



- Most pupils have an education, health and care plan. Many pupils have a diagnosis of autism.
- The school uses two unregistered alternative providers to enhance the curriculum for a small number of learners.
- There is currently no local governing body, although there are plans in place to establish one.
- The most recent inspection of the school was in February 2023. During this inspection, the school was judged as requires improvement and did not meet all of the standards. The school submitted an action plan which was judged to be likely to meet standards with modifications in June 2023.



# Information about this inspection

- This inspection was carried out at the request of the registration authority for independent schools. The purpose of the inspection was to monitor the progress the school has made in meeting the independent school standards and other requirements that it was judged to not comply with at its previous inspection.
- The registration authority for independent schools approved the use of the new Lowestoft site in August 2023. They requested this inspection to also check that the new school site met the requirements set out in paragraphs 11, 12, 16(a) and 16(b) and part 5 of the standards.
- The inspector spoke to a representative of the proprietor body, the headteacher and other senior leaders.
- The inspector scrutinised a range of documentation relating to the curriculum. This included curriculum planning guidance, assessment procedures and records of staff training. He also reviewed evidence of pupils' work in mathematics.
- The inspector reviewed the single central record and a sample of records relating to safeguarding.
- The inspector toured the new school site at Ashley House in Lowestoft, reviewed a range of documentation relating to health and safety and sampled a range of risk assessments.
