## Summary of key findings

### This provision meets requirements

- Since the last inspection, the childminder has evaluated her practice. With support from the local authority adviser, she has enhanced her policies and procedures. Overall, the childminder demonstrates a sound knowledge of the Statutory framework for the early years foundation stage. She maintains a valid first-aid certificate and is reading information on the internet to build further on her knowledge and skills.
- Following the last inspection, the childminder improved her understanding of the changes and events that need to be notified to Ofsted. As required, she informed Ofsted of a new household member, so that Ofsted could complete the suitability checking process.
- The childminder has identified a need to build on her basic knowledge of child protection and has booked a place on safeguarding training. She knows the procedure to follow if she has concerns about a child's welfare and has contact numbers for other agencies ready to use. She has suitable ways to check for any risks to children indoors, outdoors and on outings.
- The childminder understands the importance of working in partnership with parents. She has a range of ways to exchange information with parents to support children's care and their learning and development. She understands that she is required to provide parents with a written assessment of their child's progress at age two and has a suitable way to do this.
- An appropriate range of toys and books is kept accessible, so children of all ages can help themselves and develop independence. The childminder has suitable ways to observe and assess children's learning. She explains how she plans to build on what each child knows and can do as they play. She explains how she can build on children's speaking and counting skills while they look at books and play imaginatively in the role-play kitchen.
- The childminder describes suitable ways to help children to manage their feelings, behave well and respect others. She talks about supporting children's awareness of a range of cultures and faiths through stories and outings.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
