Summary of key findings

This provision meets requirements

- The childminder has a good understanding of child development. She is clear about the next steps in learning for the children in her care. The childminder talks about how she uses children's interests to extend their learning. She knows who to contact if she has any concerns about a child's development.
- The childminder explains how she ensures children develop their social skills. She understands that by attending playgroups with other childminders, the children have opportunities to socialise with others.
- The childminder talks about how she supports children's behaviour and emotional development. She understands how to teach children to share, be respectful and kind to one another.
- The childminder recognises the importance of providing children with daily fresh air and a variety of opportunities to practise their physical skills and learn about healthy lifestyles.
- The childminder describes how she will provide parents with helpful guidance on healthy foods to include in their children's packed lunches, to ensure that their meals are nutritious and balanced.
- The childminder understands her safeguarding responsibilities to protect children from harm. She knows the procedures to follow if she has concerns about a child's well-being. The childminder attends regular safeguarding training. This helps to keep her knowledge current and deepens her understanding of safeguarding issues that may affect children.
- The childminder recognises the importance of maintaining her professional development and regularly updates her childcare knowledge and training. She describes how she will evaluate her provision to improve outcomes for children.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector held a discussion with the childminder regarding safeguarding.
- The childminder described how she organises her environment and supports children's independent learning.
- The inspector considered how the childminder plans to work in partnership with parents and other professionals.
- The inspector discussed with the childminder how she intends to deliver the curriculum for children and undertake observation, assessment, and planning.
