What is it like to attend this early years setting?

The provision is good

The childminder provides a warm, nurturing, home-from-home environment. Children are happy, settled and enjoy attending the setting. They have formed close relationships with the childminder. These help children to feel safe and secure in her care. Children confidently make decisions about their play. They are deeply involved and motivated to learn. The childminder delivers learning opportunities based on the children's interests, and when they express preferences, she responds quickly.

Children enjoy tactile activities that are presented to them. For example, as they play with the dough, they name the various shapes and colours. They learn new words such as 'snip', 'track' and 'squeeze'. This supports younger children's communication and language development as well as their concentration and coordination. Children recall experiences they have enjoyed at home and with the childminder. They enthusiastically talk about a visit to a wildlife park and how they saw a parrot. The childminder praises children when they contribute to discussions. The childminder teaches the children to be independent, and routine activities are used to promote these skills. For example, young children are given the opportunity to feed themselves and to use the potty.

Children display good behaviours. They understand the rules and respond well to regular praise from the childminder. This contributes to their high levels of self-esteem.

What does the early years setting do well and what does it need to do better?

- The childminder has worked hard since the last inspection to address the weaknesses and raise the quality of the provision. She plans a curriculum based on children's individual age and stage of development. She knows children well and uses regular observations and assessments of children's learning to plan for what they need to learn next. However, very occasionally, she misses chances to encourage children to investigate and speculate during activities to help them solve problems for themselves.
- The childminder is a positive role model with regard to children's communication and language development. She is aware of the importance of building children's vocabulary, and she skilfully responds to children in a way that supports their individual needs. Children's early literacy is well supported as the childminder is keen to share a range of appropriate and interesting books with them. For instance, the childminder shares a book filled with photos. Children instantly begin to recall where they were and what they were doing. As a result of the childminder's patient modelling and effective teaching, children develop as extremely confident communicators.



- The childminder introduces children to early mathematical concepts. Children benefit from many daily opportunities that support their development of counting and their recognition of shapes. For example, children sing songs, make representations of shapes and listen to the childminder's frequent counting.
- Children are physically active and have plenty of opportunities to continually develop their small- and large-muscle movements. For example, children independently access the indoor slide and use their skills to climb and negotiate the steps and hand grips, so they can successfully slide down the ramp.
- Children develop a strong awareness of healthy lifestyles from a young age. The childminder provides children with nutritious, home-cooked snacks and meals. She teaches children that food gives them energy and all foods can be eaten in moderation. Children access fresh drinking water throughout the day and benefit from regular fresh air and exercise.
- The childminder takes pride in learning about the unique traditions that children celebrate at home. For example, they learn about their friends' heritages and how they celebrate different cultural festivals. This helps children to develop knowledge of the world around them.
- The childminder frequently seeks the thoughts and opinions of parents. Parents are delighted with the service on offer to their children. They comment on how welcoming the childminder is and how well children settle. Parents are enthusiastic about the range of experiences and activities that children get involved in and the positive impact this has on their progress.
- The childminder leads her service well, and she is committed to further developing her skill and knowledge. She attends regular training sessions and uses knowledge gained to positively impact the service on offer to children.

Safeguarding

The arrangements for safeguarding are effective.

The childminder is knowledgeable about child protection issues. She recognises the possible signs a child may be at risk of harm. She knows the local procedures she must follow to report any child protection concerns. In the event an allegation is made against herself, the childminder knows the procedures she must follow to report these concerns. The childminder carries out daily safety checks to promote children's safety in her home. For example, she is vigilant while children are sleeping and carries out regular checks to ensure that they are safe. She always supervises children during mealtimes to ensure that she can respond to their personal needs.

What does the setting need to do to improve?

To further improve the quality of the early years provision, the provider should:



provide more encouragement for children to speculate and experiment to help them solve problems for themselves.
