Inspection judgements

Overall experiences and progress of children and young people: good

Children have quickly built important and meaningful relationships with staff they can trust. Staff know the children well, listen to them and invest time in them to promote their welfare. Children continue to make progress in many aspects of their lives and experience positive outcomes. Staff speak with pride about the children's talents and achievements and ensure these are celebrated.

Staff understand the importance of children attending their education and encourage children to achieve this. One child maintains good attendance and is doing well. However, one child's attendance is variable. The manager continues to liaise with the local authority and virtual school to advocate for the child to ensure that they receive the right educational provision to meet their needs. Nonetheless educational opportunities and activity for the child outside of college are lacking.

Children are supported by staff to express themselves and have a voice. Children feel safe to share their thoughts, feelings and wishes with the adults that support them. Staff have developed an in-depth understanding of the children's needs and interests. Children are listened to, and staff positively influence children's experiences and life chances by acting on their views and wishes. For example, one child wished to watch their favourite football team play away from home, they were supported by staff to achieve this and now continue to regularly do it independently with a family member.

Staff are sensitive and responsive to children's individual needs. They treat children with dignity and respect and help children to express their views and d delicately help children to develop a positive sense of their own identity. Records are updated to reflect the voice of each child and their wishes.

Staff have developed good relationships with health professionals to promote good physical and emotional wellbeing for the children. Children have access to local health services and are supported to attend appointments when required. Children are encouraged to have a well-balanced diet and children enjoy having evening meals together with staff in the homes dining room.

How well children and young people are helped and protected: good

Staff know the children well and what individual support each child needs to be kept safe and protected from harm. Staff proactively respond to any incidents that occur, and effectively liaise with children's social workers to help reduce and minimise the risk of harm to children. Incidents remain very low, there have been no occasions where children have gone missing, and restraint has never been used. A social worker commented that staff have created a safe environment for the child and the child has staff they can trust.



Children's risk of harm is reducing and children's behavioural progress is having a positive impact on minimising their risks. Staff understand children's risks. Risk assessments reflect children's vulnerabilities and are appropriately reviewed. Guidance supports staff to know what action to take to minimise the risk to each child and protect them from harm. Records evidence that

Staff understand the risks that using the internet poses for children. Staff have proportionate restrictions in place to help keep children safe. Staff put their trust in the children and have regular discussions with them regarding healthy relationships and on-line safety, this helps support children to learn how they can keep themselves safe now and in the future.

Staff place an emphasis on the children learning important independent living skills that will give them more control and autonomy in their futures. Children are supported to take age-appropriate risks as part of their development and learn skills to help keep themselves safe. Children enjoy spending meaningful time with their friends and family in the community without any unnecessary restrictions.

The effectiveness of leaders and managers: good

The home is managed efficiently by a caring manager. Children are at the heart of every decision made and included in all aspects of the home's development. One child stated that they enjoyed living in the home and was happy.

The manager has recruited a new staff team, who have quickly built positive relationships with children and offer consistent and effective support. Staff receive regular supervision that focuses on the children's experiences and staff wellbeing.

Each child's individual needs are known by staff, and staff support the children to share their thoughts and feelings on how staff can best meet their planned needs. Records positively focus on children's talents and highlight their achievements.

Leaders, managers, and staff have established good relationships with external agencies and professionals. Feedback from professionals was positive praising the progress children were making from their starting points. A social worker commented that the child they supported receives good consistent support and staff maintain a positive environment that encourages the child to develop.

Staff expressed their joy in working at the home and supporting the children to progress. They value the support of leaders and managers, and they have access to an in-house therapies team to support their development and enhance their well-being. Staff are encouraged to gain qualifications to continue their professional development.

Records do evidence the positive impact that living at the home is having on the children. However, some handwritten records are eligible and management oversight and evaluation of some records is lacking and needs to be more robust to help inform and improve future practice.
