Main inspection findings

Part 1. Quality of education provided

- Leaders intend to extend the age range of the school from 3 to 11 to 3 to 13 years old. The school currently offers a classical Christian education to those within the primary phase. Leaders plan to now extend this into the secondary phase and have suitable plans in place for pupils who will join in Years 7 and 8.
- The school intends to offer a similar range of subjects to the primary phase as it expands into the secondary phase. This includes a range of traditional core subjects as well as other less conventional subjects, such as classical studies, visual arts, Latin and horticulture.
- The school currently teaches primary pupils in mixed-aged classes. Leaders intend to create a separate group for those in the secondary phase to provide more tailored teaching of the curriculum.
- The school has suitable plans which outline what topics will be taught each term. This shows how pupils will build and develop their knowledge and skills over time.
- Leaders have thought carefully about the content of their personal, social, health and economic (PSHE) curriculum. This will be delivered in line with the school's designated Christian character and will teach their distinctive faith perspective on relationships, with balanced debate about issues that are seen as contentious. The school will also consult with parents and carers. The PSHE curriculum also includes plans to teach all the protected characteristics.
- The school intends to provide appropriate careers advice and guidance to pupils. This includes activities and projects to develop entrepreneurial skills as well as inviting guest speakers to school from a wide range of careers.



- The school has appropriate assessment procedures in place, which they intend to continue with into the secondary phase. All pupils sit a baseline assessment on entry to the school to determine end-of-year goals alongside age-related expectations. This will continue for pupils in Years 7 and 8.
- The proprietor has ensured that the independent school standards (the standards) in this part are likely to be met if the material change application is approved.

Part 2. Spiritual, moral, social and cultural development of pupils

- The PSHE curriculum, alongside the delivery of subjects such as religious education (RE) and citizenship, has been designed to cater for pupils' spiritual, moral, social and cultural development.
- The school intends to teach pupils about fundamental British values through weekly citizenship lessons. In Year 7, leaders plan to ensure that pupils learn about democracy by studying the role of parliament, voting in elections and different political parties. Leaders also plan to ensure that pupils have a secure understanding of public institutions. The school intends to teach pupils about the role of the police as well as courts and tribunals. It also intends to teach pupils about the role of voluntary organisations. This will include working closely with a local church.
- In RE lessons, leaders intend to teach pupils about mutual respect and tolerance. This will include learning about the core beliefs of Islam in Year 7 before moving on to study Sikhism in Year 8.
- The school intends to continue with a range of extra-curricular clubs that will be available to secondary pupils. This includes clubs such as sign language, keyboard, chess and sports clubs. Pupils will also be able to attend various trips, such as visits to an arboretum, a Christian heritage centre and a sports day at a local country park.
- The proprietor has ensured that the standards in this part are likely to be met if the material change application is approved.

Part 5. Premises of and accommodation at schools

- The school has ensured that there is suitable changing accommodation and a shower room for pupils aged 11 years or over receiving physical education.
- The proprietor has ensured that the standards in this part are likely to be met if the material change application is approved.

Part 8. Quality of leadership in and management of schools

- The proprietor, who was formerly headteacher, has a strong understanding of the school. She has a background in secondary education and is passionate about a classical model of education. The school's plan to grow and develop its secondary provision at this point is entirely appropriate.
- The proprietor is ably assisted by two part-time headteachers at the school. Both headteachers have specific areas of responsibility, including oversight of different parts of the independent school standards. Both headteachers are knowledgeable about the quality of the school's work and discharge their duties, including that of safeguarding, effectively.
- The proprietor has robust procedures in place to check compliance with the independent school standards. These are tested through meetings between the proprietor and headteachers before this information is taken to governing board meetings to be scrutinised.
- The school has appropriate plans in place for its expansion to secondary-aged pupils. The proprietor has clear plans to recruit additional staff to help support the delivery of the curriculum.
- The proprietor and other leaders have pupils' well-being at the core of what they do. This is supported by the Christian virtues which sit at the heart of the school's work.
- The proprietor has ensured that the standards in this part are likely to be met if the material change application is approved.

- The school's most recent standard inspection was in September 2022, when it was judged to be good overall.
- The school does not use alternative provision.
- The school provides a classical Christian education.
- The school is currently registered to provide full-time education for boys and girls aged 3 to 11.



Information about this inspection

- The material change inspection was commissioned by the Department for Education to determine whether the school could expand the age range of its pupils from 3 to 11 to 3 to 13 years of age.
- This is the school's first material change inspection since it opened.
- Several documents were submitted electronically and were reviewed remotely by the lead inspector prior to the inspection. This included documents relating to the school's curriculum. The leader inspector also looked at the school's website.
- The lead inspector spoke with the proprietor and headteachers about safeguarding arrangements. The school's single central record was checked, as well as a sample of personnel files. The lead inspector spoke with staff and pupils about safeguarding arrangements.
- The lead inspector conducted a tour of the school site.
- The lead inspector met separately with the proprietor to discuss the leadership and management of the school.
