Summary of key findings

This provision meets requirements

- The provider and director understand their responsibilities to ensure that staff are suitable to work with children. They explain how they follow a robust recruitment procedure and will ensure that staff supervise children at all times.
- The provider and director explain how staff will provide opportunities for children to build on the physical skills they develop at school. For example, staff will provide opportunities for children to play football, hockey, target games and cricket.
- The provider and director have a good understanding of the importance of gathering information from parents about children's medical and dietary needs when they first start, to help promote children's good health.
- The provider and director understand how to help the manager and staff identify the signs and symptoms of abuse and where to report any concerns they may have regarding children's safety and welfare. They will help the manager and staff to understand where to report any concerns they may have regarding a colleague's behaviour with children.
- Through discussions with the provider and director, they demonstrate how they will support staff to keep parents updated about their children's experiences in the club. For example, they will send parents newsletters and share photos with them of activities children enjoy.
- The provider and director demonstrate an understanding of how to manage children's behaviour and to promote positive behaviour in the club. For example, supporting the manager and staff to give children praise for their achievements when they work as a team. They will give children medals for being 'player of the day'.
- The provider and director demonstrate an understanding of how to keep children safe and secure. They explain how the club has sole use of parts of the host college grounds. They will ensure that the manager and staff carry out daily risk assessments to help minimise risks to children. This will include all gates and doors being securely locked to stop unauthorised people from having access to children.
- The provider and director explain how they will support the manager and staff to help children understand how they can keep themselves safe. For example, they will practise fire drills with children, helping them to understand the procedure to follow in the event of a fire on the premises.
- The provider and director explain how they will provide children with healthy meals and drinks. They plan for staff to talk to children about making healthy food choices and the benefits these have on their bodies.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector discussed the policies and procedures with the provider and director and viewed documentation that staff will use when caring for children.
- The inspector discussed the safeguarding and welfare requirements with the provider and director.

We carried out this inspection under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the early years foundation stage.
