# Summary of key findings

#### This provision does not meet requirements

- The provider has weak understanding of the learning and development requirements. For example, she could not confidently answer questions about how she would deliver the curriculum. The provider was not able to show sufficient knowledge and understanding of the seven areas of learning in the early years foundation stage. The provider does not demonstrate an ability to plan and create coherently sequenced activities for children.
- The provider explained how she would manage behaviour in a positive way. She described using love and understanding of the individual child's needs to promote a positive environment. The provider described speaking to children in a way appropriate to their understanding and working with parents to provide consistency when dealing with behaviour.
- The provider describes how she would offer an inclusive service. She would value each child as an individual and encourage all children to value each other. This would be achieved through promoting kindness and empathy. The provider would use resources to meet a range of needs. She describes using food and games to introduce children to different cultures.
- The provider demonstrates an understanding of healthy eating and how to manage allergies. For example, she describes cooking food from scratch and providing a healthy balanced menu for the children. She explains the importance of sharing information with regards to managing allergies and keeping the children safe.
- The provider shows good understanding of storing and administering medication and provides confident answers with regards to accidents and incidents. The provider knows to keep accurate records and describes the need for confidentiality. The provider has a number of policies, however, these need to be updated to reflect current practice.
- The provider shows good understanding of child protection. She demonstrates good knowledge of procedures regarding allegations, and who to contact should there be a concern. The provider can describe how fundamental British values would be incorporated into practice. She has an awareness of the signs of abuse and what to look out for. The provider is aware of hazards and knows to keep constant supervision of the children. The provider knows to monitor the environment and visually risk assesses at home and on trips out.
- The provider has not made Ofsted aware of all household members, so that Ofsted can complete the relevant checks. This is a breach of requirements.



There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
