# **Summary of key findings**

### This provision meets requirements

- The childminder understands how to plan an appropriate curriculum that supports children's development and meets their individual needs. She explains the importance of supporting children's communication and language. For example, she intends for children to develop a love for reading through exploring books and singing rhymes.
- The childminder demonstrates an understanding of how the curriculum offers opportunities for children to learn about good oral health. She intends for children to recognise the importance of healthy eating. For example, she intends to provide a range of nutritious meals and will offer experiences to help children learn about healthy lifestyles.
- The childminder sets high expectations for children's behaviour. She has rules in place for children to learn about respect, sharing and conflict resolution. In addition, the childminder discusses the importance of working with parents to identify strategies for children to support their individual needs.
- The childminder has completed mandatory training and additional research. She understands the importance of maintaining her own professional development, to keep her knowledge and skills up to date.
- The childminder recognises the value of parent partnerships. She has procedures in place to gather key information when children settle into the setting. For example, she intends to gather information about children's needs and interests. The childminder would use this information to plan appropriate activities to support children's development. Additionally, she discusses the importance of keeping parents up to date with their children's development by sharing information about what their children know and can do.
- The childminder discusses how children will learn about the world around them. She recognises the importance of helping children to develop a sense of belonging. For example, the childminder intends to take children on visits in the community and teach them about different cultures and festivals.
- The childminder demonstrates an understanding of her role and responsibility to safeguard children. She knows the procedure to follow if an allegation is made about herself or if she has a concern about a child's welfare. Additionally, the childminder discusses how she assesses risks in her environment to make sure children would be kept safe from harm.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector discussed with the childminder how she intends to deliver the curriculum for children.
- The inspector discussed the policies and procedures with the childminder and viewed documentation that she will use when caring for children.
- The inspector discussed the safeguarding and welfare requirements with the childminder.
