Summary of key findings

This provision meets requirements

- The childminder understands her role and responsibilities for safeguarding children. She explains the possible signs and symptoms of abuse and knows to refer any concerns to the relevant agencies. She also is aware of the procedure to follow if an allegation was made against herself or any adult living or working in her home.
- The childminder demonstrates a good awareness of the learning and development requirements. She discussed how she would settle children in and assess their starting points in learning. She is aware of planning a curriculum that considers each child's age and stage of development. She has a very good range of interesting resources available for children.
- The childminder demonstrates a clear awareness of how she would support children's behaviour and emotional development. She explains how she will talk to children about the importance of being kind, learning to share and being respectful to each other.
- The childminder recognises the importance of continuous training. She has completed mandatory paediatric first-aid training and keeps up to date with any changes in early years practice or legislation.
- The childminder understands the importance of working in partnership with parents. She described how she will provide daily updates to keep parents well informed.
- The childminder understands the importance of teaching children about developing a healthy lifestyle through healthy eating and spending time outdoors being physically active.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
