Summary of key findings

This provision meets requirements

- The childminder intends to gather information from parents before children start to help support the transition into her home. She will offer families and their children gradual induction sessions to help her build relationships with them. The childminder will share information verbally at pick-up times and throughout the day using a secure online platform.
- The childminder understands child development and how children learn. She will use this knowledge and children's interests to plan meaningful experiences across all areas of the early years foundation stage. The childminder will suggest ways that families can support their children's learning at home through strategies and sharing activities to complete. Parents will be informed of local events that will complement the experiences children have with her.
- The childminder plans to take the children out into the community for different experiences. For example, she wants to promote children's imagination by using woodland areas to go on bug hunts and act out stories. She intends to use the park to develop children's physical strength as they climb on play equipment.
- The childminder intends to support children's communication and language. She will repeat words, introduce new vocabulary and ask children questions to help them develop their understanding and early language skills.
- Mathematics will be a key area of focus for the childminder, which she will integrate through her interactions with children. She plans to frequently count, use numbers and teach the children to weigh and measure using appropriate equipment, such as scales.
- The childminder knows how to support children's understanding of the world. She intends to plan activities to help children notice changes in their environment and will talk to them about the changes they see from previous visits. The childminder will use the outdoor space to grow fruits and vegetables with the children. She says children will learn how to care for the plants they grow.
- The childminder intends to support children's independence. She will support children to learn about good hygiene and manage their care needs. The childminder says she will help children persist when they find tasks difficult to build resilience and become independent.
- The childminder speaks clearly about how she intends to manage behaviour. She will praise behaviours that she expects of children. House rules will be displayed to remind children of the expectations. She intends to use positive language and model what she means, for example how to stroke her dogs safely.
- The childminder will risk assess the environment. She has suitable spaces, indoors and outdoors, for children to play. The childminder will support children to understand how to keep themselves safe. On outings, the childminder will encourage children to become 'road safe'.
- The childminder demonstrates a commitment to her professional development. She reflects on her practice and strives to improve. For example, she has plans to attend training on new funding arrangements to enable her to share this



information with families.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
