Summary of key findings

This provision does not meet requirements

- The childminder does not currently hold a paediatric first-aid certificate. This is a breach in requirements and means she cannot ensure the safety of children.
- The childminder does not demonstrate a sufficient understanding of how she will identify and support children with special educational needs and/or disabilities (SEND). She is unsure about how to acquire and obtain advice and support from professionals to ensure arrangements are put in place to support children with SEND.
- The childminder explains the topic-based curriculum that she intends to plan for children. She discusses how this is based on important skills that children need to learn, like physical development and speech and language.
- The childminder demonstrates her understanding of how to work with children speaking and learning English as an additional language. For example, she says she will learn key words in children's home language, and she will use sign language and pictures to support their understanding and development.
- The childminder understands her role in teaching children about healthy lifestyles, including making healthy food choices and being physically active. For example, this will include playing in the garden and visits to the local park.
- The childminder demonstrates a good knowledge of safeguarding and her role and responsibilities with regards to child protection. She is aware of the signs that might indicate a child is at risk of harm or abuse. The childminder has a clear understanding of the procedures to follow if she has a concern.
- The childminder discusses how she completes risk assessments and daily checks of her home and garden to help her identify and eliminate any potential risks to children's safety. She identifies aspects of her home that need to be checked on a regular basis.
- The childminder explains the strategies she will use to promote children's behaviour. She discusses how she will help children to develop their social skills, build friendships and play together.

There were no children in the early years age range present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no early years children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What does the setting need to do to improve?
