At this inspection, the inspector evaluated:

- the care of children
- the safety of children
- the effectiveness of leaders and managers.

Inspectors have looked closely at the experiences and progress of children, using the social care common inspection framework. This assurance inspection was carried out under the Care Standards Act 2000 to assess the effectiveness of the service, how it meets the core functions of the service as set out in legislation, and to consider how well it complies with The Children's Homes (England) Regulations 2015 and the 'Guide to the Children's Homes Regulations, including the quality standards'.

Findings from the inspection

We did not identify any serious or widespread concerns in relation to the care or protection of children at this assurance inspection.

The home has had a period of stability since the last inspection, which was carried out on 25 and 26 April 2023. Four children currently live at the home. A new manager was appointed on 10 March 2023 and was registered with Ofsted in July 2023. This has given the new manager the opportunity to evaluate and review the effectiveness of care provided and establish new systems and processes.

A number of requirements and recommendations were set following the home's last inspection. The manager has taken action to address each of the shortfalls. Progress in addressing the shortfalls is extensive. The manager has identified effectively the strengths in the home and the areas that need further improvement and development. There are plans in place to continue to drive improvements forward.

The children are the heart of this home. The decor and furnishings provide a welcoming environment. The home is spacious and homely, with pleasant communal areas with soft furnishings. Children's bedrooms are personalised. The gardens are also maintained to a good standard, with spaces for children to play and have fun.

The home has recently undergone a period of change, as two children have moved on, having lived at the home for a considerable time. The manager and staff ensured that the children were well prepared for their moves.

All the staff have received safeguarding training. Safeguarding issues are discussed in team meetings. Additionally, safeguarding children is also discussed in individual staff supervision. These meetings help the team to understand their safeguarding roles and responsibilities and their own professional development. The manager is also developing additional workshops specific to the needs of the children, to ensure that staff's safeguarding knowledge remains robust.

The manager and staff understand the risks to and from children. The children's individual risk assessments are clear. They provide staff with strategies to minimise risk to children and keep them safe. The manager recognises the importance of making sure that all assessments are reviewed regularly to maintain consistency in practice. This means that staff can take effective action to keep children safe when the need arises.

Supervision and monthly team meetings are taking place and are planned. These meetings provide staff with the opportunity to share concerns and develop practice.

The manager is keen to develop the skills and knowledge of her staff and is proactive in reflecting on their practice with them. Regular 'learning circles' give staff



the opportunity to reflect and learn from each other. As a result, children are receiving care from a trained and knowledgeable staff team.

The manager is passionate and ambitious for the children and staff. She leads by example and has created an incredibly positive and supportive culture in the home.
