**Overall outcome** 

The school is likely to meet the relevant independent school standards if the material change relating to the school provision is implemented

#### Main inspection findings

Part 3. Welfare, health and safety of pupils

Paragraphs 7(a)-7(b), 11, 12, 14, 16(a)-16(b), 32(1)(c) [Part 6. Provision of information]

- Leaders have created an effective culture of safeguarding. The school's comprehensive safeguarding policy reflects the latest statutory guidance. Staff regularly complete training in safeguarding, including specific training in the 'Prevent' duty and online safety.
- Staff know how to identify and report concerns on the school's secure electronic system. Detailed records indicate that safeguarding concerns are dealt with promptly. The school works proactively with external agencies to safeguard the welfare of pupils.
- The senior leadership team meet regularly to monitor ongoing safeguarding concerns. They understand the vulnerabilities of pupils at the school and adapt the range of support provided accordingly. Leaders keep the governors informed about all safeguarding matters. The school has secure safeguarding procedures in place to deal with the proposed increase in pupil numbers.
- The school has an effective health and safety policy in place. Leaders ensure that the schedule of maintenance checks complies with the health and safety policy. The school rectifies any issues promptly.
- The school complies with the relevant fire safety regulations. Leaders ensure that checks on fire safety equipment, such as fire extinguishers, take place regularly. Trained staff carry out termly fire drills. They record how well staff and pupils evacuate the building. Evacuation points are clearly signed.
- The proprietor body and governors have appropriate plans in place to increase the school's accommodation.
- There are effective supervision routines in place to prioritise pupils' safety. High staffto-pupil ratios mean that pupils are adequately supervised in class and at social times. The proposals for staff deployment and supervision are likely to be appropriate should the material change be approved.

- The school keeps detailed risk assessments that identify suitable measures to ensure the safety of pupils and staff. The school regularly reviews and updates risk assessments and pupil safety plans to ensure that they are relevant to each activity and individual pupil.
- The independent school standards (the standards) in this part are likely to be met if the request for the material change is approved.

#### Part 4. Suitability of staff, supply staff, and proprietors

Paragraphs 18(2)-18(3), 20(6)-20(6)(c), 21(1)-21(4), 21(6)-21(7)(b)

- The school has a thorough and detailed approach to recruitment of staff that ensures the necessary checks are undertaken and recorded. Senior leaders, including the chair of governors, have undertaken safer recruitment training. Appropriate preemployment checks, including checks of written references, are undertaken before staff begin working at the school.
- The school does not employ supply staff. However, they know what checks need to be carried out should it become necessary to do so in the future.
- Members of the proprietor body, MiMe Heuristics CIC, have all had the statutory checks to determine their suitability in their roles, including section 128 checks.
- The school maintain a well-organised electronic single central record. It is compliant with current guidance. The headteacher and designated safeguarding lead check the record regularly to ensure that it is accurate and complete.
- The proprietor body ensures that all confidential information about staff is stored securely. Checks ensure the safety and welfare of pupils and the suitability of staff.
- The standards in this part are likely to continue to be met if the material change is approved.

#### Part 5. Premises of and accommodation at schools

Paragraphs 23(1)(a)-23(1)(c), 24(1)-24(1)(b), 24(2), 25-29(1)(b)

- The school has ensured suitable handwashing, toilet, shower and changing facilities are available to pupils. There is access to warm water, with no risk of scalding. The number of toilets and showers is sufficient for the proposed increase in pupil numbers as additional facilities will be recommissioned for pupils' use.
- Pupils have access to suitable drinking facilities throughout the day.
- The school has appropriate first aid and medical facilities, including a bed and privacy screen. There is access to a toilet and washing facilities close by.
- Classrooms are well ventilated and benefit from natural light. Windows on the first floor have appropriate safety guards in place. The acoustic conditions of classrooms are suitable for the activities that take place in them.
- Pupils benefit from a range of outdoor spaces, including gardens, woodland, grass and concrete areas for learning, team sports and areas to socialise. Physical education such as paddle boarding activities will continue to take place off site.
- The standards in this part are likely to be met if the material change is approved.



#### Part 8. Quality of leadership in and management of schools

#### Paragraph 31(1)(a)-34(1)(c)

- The school is committed to ensuring pupils are safe and ready to learn. It will increase pupil numbers slowly to help pupils and staff build positive connections based on care and respect for each other. By working closely with local authorities, the school has identified the need for additional capacity to support vulnerable pupils in the local area. The school has given considerable thought to the extra staffing, training and learning spaces on the site to manage the growth in pupil numbers successfully.
- The proprietor body, governors and school leaders oversee the school's work effectively. The governing body monitors the quality of the school's work through regular visits. They report their findings to prioritise actions and hold leaders to account, providing appropriate challenge and support.
- Leaders at all levels demonstrate secure knowledge and understanding of the standards. Those standards considered as part of this material change inspection are likely to be met if approved by the Department for Education.
- The school is likely to meet the standard in part 8 if the material change is approved.

#### Information about this school

- The Wildings school provides places for pupils with a range of special educational needs, including those with autism spectrum disorder, or cognitive and learning needs. The school offers specialist provision for pupils with social, emotional and mental health needs.
- All pupils who attend the school have an education, health and care plan. Pupils are placed at the school by their representative local authorities.
- The school does not use any alternative provision.
- The school is owned by MiMe Heuristics, a not-for-profit community interest company. The school principal is also a director of MiMe Heuristics. The school is managed by directors with key responsibilities for the running of the company. There is also a separate governing body.
- A full standard inspection took place in June 2022, when the school was judged to require improvement.

### Information about this inspection

- The Department for Education commissioned the inspection in response to the proprietor's request to increase the maximum pupil capacity from 5 to 10. This is the first material change to the school's registration since its opening in 2021.
- During the inspection, the inspector met with pupils, the directors of the proprietor body, the headteacher and school staff. The inspector held a meeting with representatives from the governing body, including the chair of governors.
- The inspector toured the school site with the headteacher to check the suitability and safety of the premises for increased pupil numbers and the relevant standards.
- The inspector scrutinised a range of documents provided by the school, including risk assessments, health and safety records, the single central record and safeguarding information.
